Perform the operations of extracting, preparing and bottling oils, juices and other fluids in the conditions defined by the manuals of quality and procedure. Operate the relevant machinery and equipment and perform the first-level maintenance thereof.

Competence units

1. Organizing and controlling the reception, storage and dispatch of raw materials, auxiliary materials and finished products in the oil-making and juice-extracting industries.
2. Conducting the processes of extraction of oils, juices and other fluids.
3. Performing the operations of refining and correcting oils, juices and other extracted products.
4. Organizing and controlling the operations of packing and packaging of food products.
5. Applying hygiene and safety rules and controlling compliance thereof in the food-processing industry.
