Apply beauty treatments and personal aesthetics techniques; advice customers on matters within this field of competence; present and promote beauty products, implements and appliances. Administer, manage and organize a beauty parlour.

1. Removing hair by mechanical means or bleaching it in order to conceal it.
2. Apply beauty techniques to the hygiene of face and body.
3. Performing makeups adapted to the customer and to the circumstances in which they will be used.
4. Performing beauty treatments specific for hands and feet; applying manicure, pedicure and sculpture techniques, and applying nail prostheses.
5. Performing the operations of selling beauty products, implements and appliances used in cosmetics, and providing services in the field of personal aesthetics.
6. Perform the administration, management and marketing of a small company.
