3. PROFILE OF SKILLS AND COMPETENCES

The holder of this certificate will have acquired the **general competence** to carry out auxiliary operations, following instructions from a supervisor, in the assembly and maintenance of electro-technical and telecommunications infrastructures in buildings for different utilities and facilities, applying the techniques and procedures required in each case, achieving quality criteria in safety working conditions and complying with the current legislation. This general competence is divided into the following **skill units**(UC):

- Carry out operations for the installation of low voltage electrical and home automation infrastructures in buildings (UC0816_1).
- Carry out operations of installation of telecommunications infrastructures in buildings (UC0817_1).

The professional skills are acquired through the **learning outcomes** defined within the related Training Modules (MF):

- Operations of installation of low voltage electrical and home automation infrastructures in buildings (MF0816_1).
- Operations of installation of telecommunications infrastructures (MF0817_1).
- Practical training at the workplace in auxiliary operations of electro-technical and telecommunications infrastructures assembly in buildings (MP0118).

(See legal basis for all learning outcomes information acquired by the holder of this Certificate in each MF).

As a reference, the learning outcomes include in the Practical training that complete and reinforce the learning outcomes acquired in the other training modules, are:

- Assemble and machine elements of electrical and home automation installations.
- Assemble and replace the mechanisms and elements of electrical and automation facilities.
- Assemble and machine elements of telecommunications station facilities.
- Install video door station in a building.
- Participate in the working processes of the company, following the rules and instructions established at the workplace.

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THIS CERTIFICATE

The holder of the certificate work in companies dedicated to the assembly and maintenance of electrical installations in residential buildings, offices, commercial and industries facilities, being the activity regulated by the Low Voltage Electrotechnical Regulation and the Normative of Common Telecommunications Infrastructures. The most relevant occupations and work positions are:

- Assistant to the installer of communication equipment and systems.
- Assistant to the installer and fitter of telephone stations.
- Assistant to the installer and fitter of telephone and telegraph equipments.
- Assistant to the installer of TV/receiving antennas.
- Operator of low voltage electrical installations.
- Worker in the industry of production and distribution of electricity.

For working in these activities, the holder of this certificate acts always under a supervisor (installer) recognized by the competent authority in electrotechnical and telecommunications infrastructure.

5. OFFICIAL BASIS OF THE CERTIFICATE

Name and status of the national/regional authority providing accreditation/recognition of the certificate

The Ministry of Employment and Social Security or the corresponding autonomous regional administration within the scope of its competence, in the name of the King. The certificate is valid throughout Spain.

Level of the certificate

The Professional Certificate Level 1 of the National Repertoire of Professional Certificates corresponds to level 2 of the International Standard Classification of Education (ISCED-P 2011).

The European Qualification Framework (EQF) level:

Grading scale/Pass requirements

The grading scale and pass level of the training modules are expressed on a scale of 0 to 10. The minimum score for a pass is 5 in every training module including a pass in the practical training at the workplace module.

The grading system is as follows:

- FAIL: 0 to 4.9
- PASS-SATISFACTORY: 5 to 6.9
- PASS-GOOD: 7 to 8.9
- PASS-EXCELLENT: 9 to 10

Access to next level of education/training

This Professional Certificate Level 1 gives access to Professional Certificate Level 2 within the same professional area and family.

For validation purposes, the educational authorities will recognise the professional module or modules of the VET diplomas corresponding to the skills units included in the training modules of this certificate.

Legal basis

Royal Decree 683/2011, of May 13th, by which six professional certificates of the professional family "Electricity and electronics" included in the National Repertoire of professional certificates are established, and the professional certificate established as Appendix III in the Royal Decree 1214/2009 of July 17th is updated. (Appendix I, Code: ELES0208)

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

This certificate may be acquired by:

1. Training: Completion with a pass grade of the face-to-face or online training programme.
2. Recognition of the professional skills acquired through professional experience or non-formal training (prior learning): Completion of a process of skills evaluation and accreditation in all the skills units making up the professional certificate.
3. Dual training: Completion of a training and apprenticeship contract, which may range from 1 year (or 6 months, if stipulated as such in the collective agreement) to 3 years, during which effective working time is combined with time dedicated to training under the training programme for the professional certificate.

The training method (number 1 above) requires successful completion of the training modules and the practical training at the workplace:

Additional information: Professional certificates are instruments for official accreditation of the professional qualifications in the National Catalogue of Professional Qualifications for all economic activities, within the scope of the labour administration. The National Repertoire of Professional Certificates is divided into three qualification levels (Level 1, Level 2 and Level 3), and by sectors into 26 professional families and 102 professional areas.
