Professional Certificate Level 1 in IMPE0108 AUXILIARY COSMETIC SERVICES (This translation has no legal status)

3. PROFILE OF SKILLS AND COMPETENCES

The holder of this certificate will have acquired the **general competence** to embellish nails, apply hair removal techniques using mechanical tools and bleaching techniques and perform day makeup, following safety and health working rules during the service processes, and prepare the products, tools and instruments by cleaning, disinfecting or sterilizing them, all under the supervision of the technician responsible. This general competence is divided into the following **skill units**(UC):

- Prepare the equipment and perform customer care and accommodation services with quality, safety and hygiene conditions (UC0343 1).
- Apply basic cosmetic nail care (UC0344_1).
- Remove hair by mechanical means and bleach hair (UC0345 1).
- Perform day makeup (UC0346_1).

The professional skills are acquired through the learning outcomes defined within the related Training Modules (MF)

- Health and safety measures applied in beauty salons (MF0343 1).
- Basic cosmetic nail care (MF0344_1).
- Hair removal and bleaching (MF0345_1).
- Day make-up (MF0346_1).
- Practical training at the workplace in auxiliary cosmetic services (MP0070).

As a reference, the learning outcomes include in the Practical training that complete and reinforce the learning outcomes acquired in the other training modules, are:

- Do basic cleaning, disinfecting and sterilizing operations of the common tools and instruments in beauty salons.
- Apply reception, communication and information techniques to customers of cosmetic services.
- Apply basic nails and cuticles care techniques in safety and hygiene working conditions and in accordance to the customers' demands and personal features.
- Apply hair bleaching techniques depending on the characteristics of the body area, following safety and hygiene working measures.
- Apply mechanical hair removal techniques in face and body using tweezers and wax, taking into account the characteristics of the body area and following safety and hygiene working measures.
- Apply day makeup techniques following safety and hygiene measures, to get the desired results.
- Self-evaluate processes and results of cosmetic services provision.
- Participate in the working processes of the company, following the rules and instructions established at the workplace.

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THIS CERTIFICATE

The holder of this certificate may work for others in beauty and hairdressing business: beauty salons, barber shops, beauty hotel rooms, gyms, nursing homes, health resorts and SPA centers.

The most relevant occupations and work positions are:

- Manicure assistant
- Make-up assistant.

5. OFFICIAL BASIS OF THE CERTIFICATE

Name and status of the national/regional authority providing accreditation/recognition of the certificate

The Ministry of Employment and Social Security or the corresponding autonomous regional administration within the scope of its competence, in the name of the King. The certificate is valid throughout Spain.

Level of the certificate

The Professional Certificate Level 1 of the National Repertoire of Professional Certificates corresponds to level 2 of the International Standard Classification of Education (ISCED-P 2011).

The European Qualification Framework (EQF) level:

Grading scale/Pass requirements

The grading scale and pass level of the training modules are expressed on a scale of 0 to 10. The minimum score for a pass is 5 in every training module including a pass in the practical training at the workplace module.

The grading system is as follows:

- FAIL: 0 to 4.9

- PASS-SATISFACTORY: 5 to 6.9

PASS-GOOD: 7 to 8.9PASS-EXCELLENT: 9 to 10

Access to next level of education/training

This Professional Certificate Level 1 gives access to Professional Certificate Level 2 within the same professional area and family.

For validation purposes, the educational authorities will recognise the professional module or modules of the VET diplomas corresponding to the skills units included in the training modules of this certificate.

Legal basis

Royal Decree 1379/2009, August 28th, by which two professional certificates of the professional family "Personal Image" included in the National Repertoire of professional certificates are established. (Appendix II, Code: IMPE0108)

Updated by Royal Decree 716/2011, of May 20th, by which five professional certificates of the professional family "Personal Image" included in the National Repertoire of professional certificates are established, and the professional certificates established in the Royal Decree 1373/2008, of August 1st, and the professional certificates established by Royal Decree 1379/2009, of August 28th are updated.

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

This certificate may be acquired by:

- 1. Training: Completion with a pass grade of the face-to-face or online training programme.
- 2. Recognition of the professional skills acquired through professional experience or non-formal training (prior learning): Completion of a process of skills evaluation and accreditation in all the skills units making up the professional certificate.
- 3. Dual training: Completion of a training and apprenticeship contract, which may range from 1 year (or 6 months, if stipulated as such in the collective agreement) to 3 years, during which effective working time is combined with time dedicated to training under the training programme for the professional certificate.

The training method (number 1 above) requires successful completion of the training modules and the practical training at the workplace:

Additional information: Professional certificates are instruments for official accreditation of the professional qualifications in the National Catalogue of Professional Qualifications for all economic activities, within the scope of the labour administration. The National Repertoire of Professional Certificates is divided into three qualification levels (Level 1, Level 2 and Level 3), and by sectors into 26 professional families and 102 professional areas.
