3. PROFILE OF SKILLS AND COMPETENCES

The holder of this certificate will have acquired the **general competence** to prepare the equipment, clean and condition hair and scalp and apply form and colour changing techniques, under the supervision of the technical responsible, following hygiene and safety working measures requirements. This general competence is divided into the following **skill units**(UC):

- Prepare equipment and wash and condition hair and scalp (UC0058_1).
- Prepare the hair for temporary and permanent shape changes and the start of the hairstyling (UC0059_1).
- Apply hair colour and bleaching techniques (UC0060_1).

The professional skills are acquired through the **learning outcomes** defined within the related Training Modules (MF):

- Hygiene and sterility requirements applied to hairdressing (MF0058_1).
- Preparation of hair for changes in shape and start of the hairstyling (MF0059_1).
- Application of cosmetics for hair color changes (MF0060_1).
- Practical training at the workplace in auxiliary hairdressing services (MP0069).

As a reference, the learning outcomes include in the Practical training that complete and reinforce the learning outcomes acquired in the other training modules, are:

- Choose the appropriate method of hygiene, disinfection and sterilization of equipment and working areas, according to the elements.
- Apply hair cleaning and conditioning techniques according to each client in safety working condition and with excellent cosmetic results.
- Place the molds or other accessories to obtain temporarily hair changes.
- Carry out permanent changes in shape techniques.
- Apply hair colour and bleaching techniques using the appropriate security and hygiene working measures.
- Participate in the working processes of the company, following the rules and instructions established at the workplace.

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THIS CERTIFICATE

The holder of the certificate may work for others in hairdressing business and in economic sectors where hairdressing jobs are developed. The most relevant occupation is:

- Assistant to hairdresser.

5. OFFICIAL BASIS OF THE CERTIFICATE

Name and status of the national/regional authority providing accreditation/recognition of the certificate

The Ministry of Employment and Social Security or the corresponding autonomous regional administration within the scope of its competence, in the name of the King. The certificate is valid throughout Spain.

Level of the certificate

The Professional Certificate Level 1 of the National Repertoire of Professional Certificates corresponds to level 2 of the International Standard Classification of Education (ISCED-P 2011).

The European Qualification Framework (EQF) level:

Grading scale/Pass requirements

The grading scale and pass level of the training modules are expressed on a scale of 0 to 10. The minimum score for a pass is 5 in every training module including a pass in the practical training at the workplace module.

The grading system is as follows:

- FAIL: 0 to 4.9
- PASS-SATISFACTORY: 5 to 6.9
- PASS-GOOD: 7 to 8.9
- PASS-EXCELLENT: 9 to 10

Access to next level of education/training

This Professional Certificate Level 1 gives access to Professional Certificate Level 2 within the same professional area and family.

For validation purposes, the educational authorities will recognise the professional module or modules of the VET diplomas corresponding to the skills units included in the training modules of this certificate.

Legal Basis

Royal Decree 1379/2009, of August 28th, by which two professional certificates of the professional family "Personal Image" included in the National Repertoire of professional certificates are established. (Appendix I, Code: IMPQ0108)

Updated by Royal Decree 716/2011, of May 20th, by which five professional certificates of the professional family "Personal Image" included in the National Repertoire of professional certificates are established, and the professional certificates established by the Royal Decree 1373/2008, of August 1st, and the certificates established by Royal Decree 1379/2009, of August 28th are updated.

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

This certificate may be acquired by:

1. Training: Completion with a pass grade of the face-to-face or online training programme.
2. Recognition of the professional skills acquired through professional experience or non-formal training (prior learning): Completion of a process of skills evaluation and accreditation in all the skills units making up the professional certificate.
3. Dual training: Completion of a training and apprenticeship contract, which may range from 1 year (or 6 months, if stipulated as such in the collective agreement) to 3 years, during which effective working time is combined with time dedicated to training under the training programme for the professional certificate.

The training method (number 1 above) requires successful completion of the training modules and the practical training at the workplace:

Additional information: Professional certificates are instruments for official accreditation of the professional qualifications in the National Catalogue of Professional Qualifications for all economic activities, within the scope of the labour administration. The National Repertoire of Professional Certificates is divided into three qualification levels (Level 1, Level 2 and Level 3), and by sectors into 26 professional families and 102 professional areas.
