3. PROFILE OF SKILLS AND COMPETENCES

The holder of this certificate will have acquired the **general competence** to operate machining equipment for the manufacture of carpentry and furniture elements, adjust and package products and elements of carpentry and furniture and assist in their assembly and installation with the required quality and complying with the occupational health and safety requirements and environmental protection measures. This general competence is divided into the following **skill units**(UC):

- Mechanize wood and its by-products (UC0162_1).
- Adjust and package products and carpentry and furniture elements (UC0173_1).
- Assist in the assembly and installation of carpentry and furniture elements (UC0882 1).

The professional skills are acquired through the learning outcomes defined within the related Training Modules (MF):

- Mechanizing of wood and its by-products (MF0162 1).
- Adjusting and packaging of carpentry and furniture elements (MF0173_1).
- Assembly and installation of carpentry and furniture elements (MF0882 1).
- Practical training at the workplace in carpentry and furniture works (MP0056).

As a reference, the learning outcomes include in the Practical training that complete and reinforce the learning outcomes acquired in the other training modules, are:

- Do the manufacturing of a piece of furniture or mechanized carpentry.
- Obtain mechanized products with industrial machines.
- Do the manual supply operations of the main industrial machines, obtaining pieces with the dimensional characteristics and the required quality.
- Assembly and package furniture and carpentry elements.
- Interpret assembly and installation drawings of furniture and carpentry elements by checking the lists of materials, installation location and proposed measurements.
- Perform, according to the blueprint specifications, the fixing of the installation components.
- Apply the rules in the machining process, handling as well as in the setting and packaging of furniture and carpentry elements.
- Participate in the working processes of the company, following the rules and instructions established at the workplace.

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THIS CERTIFICATE

The holder of this certificate may work in companies engaged in the manufacture of furniture and carpentry elements. The most relevant occupations and work positions are:

- Woodworking products assembler in general.
- Assembler of wooden furniture or similar.
- Wood products assembler, except woodwork.
- Packer, tagger.
- Worker of the wood and cork industry.

5. OFFICIAL BASIS OF THE CERTIFICATE

Name and status of the national/regional authority providing accreditation/recognition of the certificate

The Ministry of Employment and Social Security or the corresponding autonomous regional administration within the scope of its competence, in the name of the King. The certificate is valid throughout Spain.

Level of the certificate

The Professional Certificate Level 1 of the National Repertoire of Professional Certificates corresponds to level 2 of the International Standard Classification of Education (ISCED-P 2011).

The European Qualification Framework (EQF) level:

Grading scale/Pass requirements

The grading scale and pass level of the training modules are expressed on a scale of 0 to 10. The minimum score for a pass is 5 in every training module including a pass in the practical training at the workplace module.

The grading system is as follows:

FAIL: 0 to 4.9

PASS-SATISFACTORY: 5 to 6.9

PASS-GOOD: 7 to 8.9PASS-EXCELLENT: 9 to 10

Access to next level of education/training

This Professional Certificate Level 1 gives access to Professional Certificate Level 2 within the same professional area and family.

For validation purposes, the educational authorities will recognise the professional module or modules of the VET diplomas corresponding to the skills units included in the training modules of this certificate.

Legal basis

Royal Decree 717/2011, of May 20th, by which six professional certificates of the professional family "Wood, furniture and cork", included in the National Repertoire of professional certificates are established (Appendix II, Code: MAMD0209).

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

This certificate may be acquired by:

- 1. Training: Completion with a pass grade of the face-to-face or online training programme.
- 2. Recognition of the professional skills acquired through professional experience or non-formal training (prior learning): Completion of a process of skills evaluation and accreditation in all the skills units making up the professional certificate.
- 3. Dual training: Completion of a training and apprenticeship contract, which may range from 1 year (or 6 months, if stipulated as such in the collective agreement) to 3 years, during which effective working time is combined with time dedicated to training under the training programme for the professional certificate.

The training method (number 1 above) requires successful completion of the training modules and the practical training at the workplace:

Additional information: Professional certificates are instruments for official accreditation of the professional qualifications in the National Catalogue of Professional Qualifications for all economic activities, within the scope of the labour administration. The National Repertoire of Professional Certificates is divided into three qualification levels (Level 1, Level 2 and Level 3), and by sectors into 26 professional families and 102 professional areas.
