3. PROFILE OF SKILLS AND COMPETENCES

The holder of this certificate will have acquired the **general competence** to cleaning up tasks in open spaces, industrial facilities and equipment, using the means, tools and vehicles of less than 3,500 kilograms, appropriate to each space and / or equipment to achieve the optimum level of cleanliness, hygiene and beautification. This general competence is divided into the following **skill units**(UC):

- Carry out the cleaning tasks in open spaces (UC1313_1).
- Carry out the cleaning tasks in industrial facilities and equipment (UC1314_1).

The professional skills are acquired through the **learning outcomes** defined within the related Training Modules (MF):

- Cleaning in open spaces (MF1313_1).
- Cleaning in industrial facilities and equipment (MF1314_1).
- Practical training at the workplace in cleaning in open spaces and industrial facilities (MP0242).

(See legal basis for all learning outcomes information acquired by the holder of this Certificate in each MF).

As a reference, the learning outcomes include in the Practical training that complete and reinforce the learning outcomes acquired in the other training modules, are:

- Carry out the manual and mechanical sweeping of open public spaces, using means, tools and vehicles of less than 3,500 kilograms.
- Perform the washing down and scrubbing of open spaces, using vehicles of less than 3,500 kilograms.
- Undertake the cleaning of special areas using vehicles of less than 3,500 kilograms safely adapted to the working area.
- Clean the open spaces in situations of immediate action, using the means, tools and vehicles of less than 3,500 kg, taking in consideration the impact generated by the event or cause, for its prompt normal use.
- Develop the cleaning operation of drainage elements, vertical walls and urban furniture, maintaining its hygienic and beauty.
- Carry out the cleaning of beaches using means, tools and vehicles of less than 3,500 kilograms.
- Perform the disinfection and cleaning, wet and / or dry, of surfaces, tanks and containers.
- Clean tanks and confined spaces, wet and / or dry, achieving the required level of hygiene.
- Implement preventive measures and actions related to occupational risks prevention resulting from the cleaning up of open spaces and equipment and industrial environments.
- Participate in the working processes of the company, following the rules and instructions established at the workplace.

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THIS CERTIFICATE

The holder of the certificate may work in the area of urban and industrial facilities cleaning. The most relevant occupations and work positions are:

- Labourer garbage collector, landfill.
- Sweeper.
- Sewer maintenance operator .
- Road cleaning and related operator .
- Labourer waste collector.

5. OFFICIAL BASIS OF THE CERTIFICATE

Name and status of the national/regional authority providing accreditation/recognition of the certificate

The Ministry of Employment and Social Security or the corresponding autonomous regional administration within the scope of its competence, in the name of the King. The certificate is valid throughout Spain.

Level of the certificate

The Professional Certificate Level 1 of the National Repertoire of Professional Certificates corresponds to level 2 of the International Standard Classification of Education (ISCED-P 2011).

The European Qualification Framework (EQF) level:

Grading scale/Pass requirements

The grading scale and pass level of the training modules are expressed on a scale of 0 to 10. The minimum score for a pass is 5 in every training module including a pass in the practical training at the workplace module.

The grading system is as follows:

- FAIL: 0 to 4.9
- PASS-SATISFACTORY: 5 to 6.9
- PASS-GOOD: 7 to 8.9
- PASS-EXCELLENT: 9 to 10

Access to next level of education/training

This Professional Certificate Level 1 gives access to Professional Certificate Level 2 within the same professional area and family.

For validation purposes, the educational authorities will recognise the professional module or modules of the VET diplomas corresponding to the skills units included in the training modules of this certificate.

Legal basis

Royal Decree 720/2011, of May 20th, by which three professional certificates of the professional family Security and Environment included in the National Repertoire of professional certificates are established. (Appendix I, Code: SEAG0209)

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

This certificate may be acquired by:

1. Training: Completion with a pass grade of the face-to-face or online training programme.
2. Recognition of the professional skills acquired through professional experience or non-formal training (prior learning): Completion of a process of skills evaluation and accreditation in all the skills units making up the professional certificate.
3. Dual training: Completion of a training and apprenticeship contract, which may range from 1 year (or 6 months, if stipulated as such in the collective agreement) to 3 years, during which effective working time is combined with time dedicated to training under the training programme for the professional certificate.

The training method (number 1 above) requires successful completion of the training modules and the practical training at the workplace:

Additional information: Professional certificates are instruments for official accreditation of the professional qualifications in the National Catalogue of Professional Qualifications for all economic activities, within the scope of the labour administration. The National Repertoire of Professional Certificates is divided into three qualification levels (Level 1, Level 2 and Level 3), and by sectors into 26 professional families and 102 professional areas.
