## 3. PROFILE OF SKILLS AND COMPETENCES

The holder of this certificate will have acquired the **general competence** to carry out the classification, washing and fixing of textile manufactures in industrial and local establishments, applying the techniques and procedures required in each case, under the supervision of a responsible for producing the required quality and within the time required and complying with environmental and safety conditions established in occupational risks prevention plan. This general competence is divided into the following **skill units**(UC):

- Receive, classify and prepare clothes for cleaning (UC0434\_1).
- Carry out the wet cleaning of clothes (UC0435\_1).
- Carry out the dry cleaning of clothes (UC0436\_1).
- Carry out the drying, ironing and folding of clothes (UC0437\_1).

The professional skills are acquired through the **learning outcomes** defined within the related Training Modules (MF):

- Textile materials and goods (MF0434\_1).
  - Wet cleaning of clothes (MF0435\_1).
  - Dry cleaning of clothes (MF0436\_1).
  - Drying, ironing and folding of clothes (MF0437\_1).
  - Practical training at the workplace in auxiliary operations of industrial and proximity laundry (MP0545).
- (See legal basis for all learning outcomes information acquired by the holder of this Certificate in each MF).

As a reference the learning outcomes include in the Practical training at the workplace that complete and reinforce the learning outcomes acquired in the other training modules, are:

- Participate in the reception and storage of cleaning supplies, following the rules and instructions established at the workplace.
- Prepare and sort the laundry to select and make the process of maintenance and upkeep, acting under safety standards.
- Carry out the wet or dry cleaning.
- Carry out the final processes and product presentation following the quality controls established by the company.
- Participate in the working processes of the company, following the rules and instructions established at the workplace.

#### 4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THIS CERTIFICATE

The holder of this certificate may work in large, medium and small companies of industrial laundry services (dry and water cleaning), proximity laundry services and/or in establishments engaged in other economic activities that have their own local facilities.

The most relevant occupations and work positions are:

- Washing machines operators (laundry services).
- Drying machines operators (laundry services).
- Ironing machines operators (laundry services and similar).
- Lingerers-laundrers-pressers (hospitality services).
- Cleaning and/or dryers machines operators (laundry services).

#### 5. OFFICIAL BASIS OF THE CERTIFICATE

##### **Name and status of the national/regional authority providing accreditation/recognition of the certificate**

The Ministry of Employment and Social Security or the corresponding autonomous regional administration within the scope of its competence, in the name of the King. The certificate is valid throughout Spain.

##### **Level of the certificate**

The Professional Certificate Level 1 of the National Repertoire of Professional Certificates corresponds to level 2 of the International Standard Classification of Education (ISCED-P 2011).

The European Qualification Framework (EQF) level:

##### **Grading scale/Pass requirements**

The grading scale and pass level of the training modules are expressed on a scale of 0 to 10. The minimum score for a pass is 5 in every training module including a pass in the practical training at the workplace module.

The grading system is as follows:

- FAIL: 0 to 4.9
- PASS-SATISFACTORY: 5 to 6.9
- PASS-GOOD: 7 to 8.9
- PASS-EXCELLENT: 9 to 10

##### **Access to next level of education/training**

This Professional Certificate Level 1 gives access to Professional Certificate Level 2 within the same professional area and family.

For validation purposes, the educational authorities will recognise the professional module or modules of the VET diplomas corresponding to the skills units included in the training modules of this certificate.

##### **Legal basis**

Royal Decree 991/2013 of December 13th, by which twenty-five professional certificates of the professional family Textile, clothing and leather, included in the National Repertoire of professional certificates are established, and the professional certificate established as Appendix IV of Royal Decree 722/2011, of May 20th (Appendix I, Code: TCPN0312) is updated.

## 6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

This certificate may be acquired by:

1. Training: Completion with a pass grade of the face-to-face or online training programme.
2. Recognition of the professional skills acquired through professional experience or non-formal training (prior learning): Completion of a process of skills evaluation and accreditation in all the skills units making up the professional certificate.
3. Dual training: Completion of a training and apprenticeship contract, which may range from 1 year (or 6 months, if stipulated as such in the collective agreement) to 3 years, during which effective working time is combined with time dedicated to training under the training programme for the professional certificate.

The training method (number 1 above) requires successful completion of the training modules and the practical training at the workplace:

**Additional information:** Professional certificates are instruments for official accreditation of the professional qualifications in the National Catalogue of Professional Qualifications for all economic activities, within the scope of the labour administration. The National Repertoire of Professional Certificates is divided into three qualification levels (Level 1, Level 2 and Level 3), and by sectors into 26 professional families and 102 professional areas.
