#### 3. PROFILE OF SKILLS AND COMPETENCES

The holder of this certificate will have acquired the **general competence** to perform auxiliary maintenance of structural elements of wood and fiber, as well as surface protection and embellishment of sport and recreational boats, including those with restricted length dedicated to other services or functions, following instructions and in compliance with the rules of occupational and environmental risks prevention. This general competence is divided into the following **skill units**(UC):

- Perform auxiliary operations of surface protection and embellishment of sports and recreational boats (UC1455\_1).
- Perform auxiliary operations repair of wooden elements of sports and recreational boats (UC1456 1).
- Perform auxiliary repair operations of reinforced plastic elements on sports and recreational boats (UC1457\_1).

The professional skills are acquired through the learning outcomes defined within the related Training Modules (MF):

- Auxiliary operations of protection and embellishment of surfaces on sports and recreational boats (MF1455\_1).
- Auxiliary operations of repair of wooden elements of sports and recreational boats (MF1456\_1).
- Auxiliary operations of repair of reinforced plastic elements of sports and recreational boats (MF1457 1).
- Practical training at the workplace in auxiliary maintenance operations of structural and coating elements in sports and recreational boat surfaces (MP0346).

As a reference, the learning outcomes include in the Practical training that complete and reinforce the learning outcomes acquired in the other training modules, are:

- Participate in the preparation of the vessel to perform the planned maintenance work.
- Perform basic maintenance and conservation operations on the various recreational boats equipments.
- Participate in the working processes of the company, following the rules and instructions established at the workplace.

#### 4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THIS CERTIFICATE

The holder of the certificate exercises his/her activity in shipbuilding of yachts and sport boats; as well as repair and ship maintenance. The most relevant occupations and work positions are:

- Assistant craft painter.
- Assistant boat builder/carpenter.
- Maintenance assistant of elements made of plastic reinforced with fiber.

# Name and status of the national/regional authority providing accreditation/recognition of the certificate

The Ministry of Employment and Social Security or the corresponding autonomous regional administration within the scope of its competence, in the name of the King. The certificate is valid throughout Spain.

#### Level of the certificate

The Professional Certificate Level 1 of the National Repertoire of Professional Certificates corresponds to level 2 of the International Standard Classification of Education (ISCED-P 2011).

## **Grading scale/Pass requirements**

The grading scale and pass level of the training modules are expressed on a scale of 0 to 10. The minimum score for a pass is 5 in every training module including a pass in the practical training at the workplace module.

The grading system is as follows:

- FAIL: 0 to 4.9

PASS-SATISFACTORY: 5 to 6.9

PASS-GOOD: 7 to 8.9PASS-EXCELLENT: 9 to 10

## Access to next level of education/training

This Professional Certificate Level 1 gives access to Professional Certificate Level 2 within the same professional area and family.

For validation purposes, the educational authorities will recognise the professional module or modules of the VET diplomas corresponding to the skills units included in the training modules of this certificate.

#### **Legal basis**

Royal Decree 1539/2011, of October 31st, by which seven professional certificates of the professional family Transport and Vehicle Maintenance, included in the National Repertoire of professional certificates are established (Appendix II, Code: TMVU0210).

#### 6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

This certificate may be acquired by:

- 1. Training: Completion with a pass grade of the face-to-face or online training programme.
- 2. Recognition of the professional skills acquired through professional experience or non-formal training (prior learning): Completion of a process of skills evaluation and accreditation in all the skills units making up the professional certificate.
- 3. Dual training: Completion of a training and apprenticeship contract, which may range from 1 year (or 6 months, if stipulated as such in the collective agreement) to 3 years, during which effective working time is combined with time dedicated to training under the training programme for the professional certificate.

The training method (number 1 above) requires successful completion of the training modules and the practical training at the workplace:

**Additional information:** Professional certificates are instruments for official accreditation of the professional qualifications in the National Catalogue of Professional Qualifications for all economic activities, within the scope of the labour administration. The National Repertoire of Professional Certificates is divided into three qualification levels (Level 1, Level 2 and Level 3), and by sectors into 26 professional families and 102 professional areas.
