3. PROFILE OF SKILLS AND COMPETENCES

The holder of this certificate will have acquired the **general competence** to handle equines during the foal's training and basic dressage in order to achieve their proper physical and behavioural performance and their correct disposition for subsequent initiation in each of the possible equestrian disciplines or pursuits taking in consideration animal welfare criteria and the occupational risks prevention and environmental protection regulations. This general competence is divided into the following **skill units**(UC):

- Mastering the basic techniques of horseback riding (UC1080_2).
- Handle foals (UC1122_2).
- Dressage foals with a lunge (UC1123_2).
- Carry out the initial riding of foals (UC1124_2).

The professional skills are acquired through the **learning outcomes** defined within the related Training Modules (MF):

- Basic techniques of horseback riding (MF1080_2).
- Foals taming (MF1122_2).
- Lungeing dressage of foals (MF1123_2).
- Initial riding of foals (MF1124_2).
- Practical training at workplace in basic horse dressage (MP0300).

(See legal basis for all learning outcomes information acquired by the holder of this Certificate in each MF).

As a reference the learning outcomes include in the Practical training at the workplace that complete and reinforce the learning outcomes acquired in the other training modules, are:

- Participate in the taming of rearing foals, fulfilling the farm protocols.
- Participate in the first contacts with foals using lunges for training, and collaborating with the farm staff in preparation and implementation them.
- Collaborate in the work of dressage using a line/rope, handling the animal or acting as an auxiliary in the ground training if we are indicated to do so.
- Place the saddle and riding equipment on the foal, adapting and adjusting it to the characteristics of the animal.
- Participate in the work of riding a foal, working with the farm staff during its training.
- Participate in the working processes of the company, following the rules and instructions established at the workplace.

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THIS CERTIFICATE

The holder of this certificate may work in the equine farm sector and services associated with this type of animal family, in the following economic activities: farms of equidae and horses; companies and entities associated with events, shows, equestrian demonstrations, recreational activities, sports and equine assisted therapeutic activities (hippotherapy); horse training centers, dressage and training of horses; Public or private farms of stallions and mares; training, rest and recovery centers for horses; and service companies related to the equine industry. The most relevant occupations and work positions are:

- Horse breeding worker.
- Horse tamer and/or trainer
- Employee for foals dressage in equine farms.
- Employee for foals dressage in training centers and horse training.
- Employee for foal dressage in boarding, rest and recovery centres of horses.
- Employee for foal dressage in stallions stops, selection and growth test centers and stud farms, both public and private.
- Employee in service companies related to the sector.

5. OFFICIAL BASIS OF THE CERTIFICATE

Name and status of the national/regional authority providing accreditation/recognition of the certificate

The Ministry of Employment and Social Security or the corresponding autonomous regional administration within the scope of its competence, in the name of the King. The certificate is valid throughout Spain.

Level of the certificate

The Professional Certificate Level 2 of the National Repertoire of Professional Certificates corresponds to level 3 of the International Standard Classification of Education (ISCED-P 2011).

The European Qualification Framework (EQF) level:

Grading scale/Pass requirements

The grading scale and pass level of the training modules are expressed on a scale of 0 to 10. The minimum score for a pass is 5 in every training module including a pass in the practical training at the workplace module.

The grading system is as follows:

- FAIL: 0 to 4.9
- PASS-SATISFACTORY: 5 to 6.9
- PASS-GOOD: 7 to 8.9
- PASS-EXCELLENT: 9 to 10

Access to next level of education/training

This Professional Certificate Level 2 gives access to Professional Certificate Level 3 within the same professional area and family.

For validation purposes, the educational authorities will recognise the professional module or modules of the VET diplomas corresponding to the skills units included in the training modules of this certificate.

Legal basis

Royal Decree 1519/2011, of October 31st, by which seven professional certificates of the Professional Family of Agriculture, included in the National Repertoire of professional certificates are established. (Appendix I, Code: AGAN0110)

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

his certificate may be acquired by:

1. Training: Completion with a pass grade of the face-to-face or online training programme.
2. Recognition of the professional skills acquired through professional experience or non-formal training (prior learning): Completion of a process of skills evaluation and accreditation in all the skills units making up the professional certificate.
3. Dual training: Completion of a training and apprenticeship contract, which may range from 1 year (or 6 months, if stipulated as such in the collective agreement) to 3 years, during which effective working time is combined with time dedicated to training under the training programme for the professional certificate.

The training method (number 1 above) requires successful completion of the training modules and the practical training at the workplace:

Entry/access requirements:

- Compulsory Secondary Education Diploma (Lower secondary education); or
- Professional Certificate Level 1 in the same professional area.
- If neither of the above or higher certifications are held, a pass in the key skills tests.

Additional information: Professional certificates are instruments for official accreditation of the professional qualifications in the National Catalogue of Professional Qualifications for all economic activities, within the scope of the labour administration. The National Repertoire of Professional Certificates is divided into three qualification levels (Level 1, Level 2 and Level 3), and by sectors into 26 professional families and 102 professional areas.
