3. PROFILE OF SKILLS AND COMPETENCES

The holder of this certificate will have acquired the **general competence** to run the intensive pig production and handling as the current standard and specifications, to produce piglets in the most optimized way possible, according to criteria of animal welfare, occupational risks prevention, environmental protection and food safety. This general competence is divided into the following **skill units**(UC):

- Carry out the production operations of sows, breeding pigs and piglets (UC0004_2).
- Assemble and maintain the facilities, machinery and equipment of the animals farm (UC0006 2).

The professional skills are acquired through the learning outcomes defined within the related Training Modules (MF):

- Production of pigs for renewing, breeding and piglets (MF0004_2).
- Facilities, machinery and equipment of the animal farm (MF0006 2).
- Practical training at the workplace in pig production for reproduction and breeding (MP0036).

(See legal basis for all learning outcomes information acquired by the holder of this Certificate in each MF).

As a reference the learning outcomes include in the Practical training at the workplace that complete and reinforce the learning outcomes acquired in the other training modules, are:

- Describe feeding care of sows for breeding and renew and piglets to have an optimal performance and according to established protocols.
- Recognize the necessary actions to detect heat, cover, pregnancy, childbirth, postpartum and lactation to optimize reproductive performance of a breeding swine.
- Participate in the working processes of the company, following the rules and instructions established at the workplace.

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THIS CERTIFICATE

The holder of the certificate may work in sectors related to pig farming and services associated to this kind of farms. The most relevant occupations and work positions are:

- Agricultural and livestock technician.
- Skilled worker on farms.
- Assistant in swine artificial insemination.
- Pig farms qualified worker.

5. OFFICIAL BASIS OF THE CERTIFICATE

Name and status of the national/regional authority providing accreditation/recognition of the certificate

The Ministry of Employment and Social Security or the corresponding autonomous regional administration within the scope of its competence, in the name of the King. The certificate is valid throughout Spain.

Level of the certificate

The Professional Certificate Level 2 of the National Repertoire of Professional Certificates corresponds to level 3 of the International Standard Classification of Education (ISCED-P 2011).

The European Qualification Framework (EQF) level:

Grading scale/Pass requirements

The grading scale and pass level of the training modules are expressed on a scale of 0 to 10. The minimum score for a pass is 5 in every training module including a pass in the practical training at the workplace module.

The grading system is as follows:

FAIL: 0 to 4.9

PASS-SATISFACTORY: 5 to 6.9

PASS-GOOD: 7 to 8.9PASS-EXCELLENT: 9 to 10

Access to next level of education/training

This Professional Certificate Level 2 gives access to Professional Certificate Level 3 within the same professional area and family.

For validation purposes, the educational authorities will recognise the professional module or modules of the VET diplomas corresponding to the skills units included in the training modules of this certificate.

Legal basis

Royal Decree 1375/2008, of August 1st, by which twelve professional certificates of the Professional Family of Agriculture, included in the National Repertoire of professional certificates are established. (Appendix XI, Code: AGAP0108)

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

This certificate may be acquired by:

- 1. Training: Completion with a pass grade of the face-to-face or online training programme.
- Recognition of the professional skills acquired through professional experience or non-formal training (prior learning): Completion of a process of skills evaluation and accreditation in all the skills units making up the professional certificate.
- 3. Dual training: Completion of a training and apprenticeship contract, which may range from 1 year (or 6 months, if stipulated as such in the collective agreement) to 3 years, during which effective working time is combined with time dedicated to training under the training programme for the professional certificate.

The training method (number 1 above) requires successful completion of the training modules and the practical training at the workplace:

Entry/access requirements:

- Compulsory Secondary Education Diploma (Lower secondary education); or
- Professional Certificate Level 1 in the same professional area.
- If neither of the above or higher certifications are held, a pass in the key skills tests.

Additional information: Professional certificates are instruments for official accreditation of the professional qualifications in the National Catalogue of Professional Qualifications for all economic activities, within the scope of the labour administration. The National Repertoire of Professional Certificates is divided into three qualification levels (Level 1, Level 2 and Level 3), and by sectors into 26 professional families and 102 professional areas.
