## 3. PROFILE OF SKILLS AND COMPETENCES

The holder of this certificate will have acquired the **general competence** to install and maintain telephony network equipment, related to transmission and switching systems and radio controllers, mobile telephony base stations and auxiliary systems, fulfilling quality criteria, complying with the company's occupational and environmental risk prevention plans and applicable regulations. This general competence is divided into the following **skills units** (UC):

- Install telephony base stations (UC1562\_2).
- Maintain telephony base stations (UC1563\_2).
- Install telephone network telecommunications systems (UC1564\_2).
- Maintain telephone network telecommunications systems (UC1565\_2).

The professional skills are acquired through the **learning outcomes** defined within the related Training Modules (MF):

- Installation of telephony base stations (MF1562\_2).
- Maintenance of telephony base stations (MF1563\_2).
- Installation of telephone network telecommunications systems (MF1564\_2).
- Maintenance of telephone network telecommunications systems (MF1565\_2).
- Practical training at the workplace in installation and maintenance of network equipment and telephony base stations (MP0418).

(See legal basis for all learning outcomes information acquired by the holder of this Certificate in each MF).

As a reference the learning outcomes include in the Practical training at the workplace that complete and reinforce the learning outcomes acquired in the other training modules, are:

- Lay cabling for installation of telephony base stations and telephone network telecommunications systems based on technical documentation following safety standards.
- Install radiating systems, equipment and auxiliary elements for telephony base stations and telephone network telecommunication systems, based on technical documentation, following safety standards.
- Diagnose faults or breakdowns of telephony base stations equipment and installations and of telephone network telecommunications systems, locating and identifying them, determining the cause, implementing required procedures with safety conditions.
- Repair previously diagnosed breakdowns or faults in telephony base stations or telephone network telecommunications equipment, using procedures, means and tools with safety conditions and required quality.
- Take part in the company's working processes, following the rules and instructions established at the workplace.

#### 4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THIS CERTIFICATE

The holder of this certificate may work in companies devoted to installing telecommunications equipment and systems (telephone exchanges, base stations, voice and data network systems and cabling, radio data links, among others), in the area of telephone system installation and maintenance. The holder may also work in telecommunications, specifically in the following business activities: cable telecommunications and wireless telecommunications. The most pertinent occupations and positions are:

- Communications electronics technician.
- Telecommunications technician.
- Installer of telecommunications equipments and systems.
- Repairer of communications installations and/or systems.
- Telephone system maintenance technician.

#### 5. OFFICIAL BASIS OF THE CERTIFICATE

##### **Name and status of the national/regional authority providing accreditation/recognition of the certificate**

The Ministry of Employment and Social Security or the corresponding autonomous regional administration within the scope of its competence, in the name of the King. The certificate is valid throughout Spain.

##### **Level of the certificate**

The Professional Certificate Level 2 of the National Repertoire of Professional Certificates corresponds to level 3 of the International Standard Classification of Education (ISCED-P 2011).

The European Qualification Framework (EQF) level:

##### **Grading scale/Pass requirements**

The grading scale and pass level of the training modules are expressed on a scale of 0 to 10. The minimum score for a pass is 5 in every training module including a pass in the practical training at the workplace module.

The grading system is as follows:

- FAIL: 0 to 4.9
- PASS-SATISFACTORY: 5 to 6.9
- PASS-GOOD: 7 to 8.9
- PASS-EXCELLENT: 9 to 10

##### **Access to next level of education/training**

This Professional Certificate Level 2 gives access to Professional Certificate Level 3 within the same professional area and family.

For validation purposes, the educational authorities will recognise the professional module or modules of the VET diplomas corresponding to the skills units included in the training modules of this certificate.

##### **Legal basis**

Royal Decree 1077/2012 of 13 July, establishing five professional certificates in the professional family Electricity and Electronics, which are included in the National Repertoire of Professional Certificates. (Appendix II Code: ELES0111)

## 6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

This certificate may be acquired by:

1. Training: Completion with a pass grade of the face-to-face or online training programme.
2. Recognition of the professional skills acquired through professional experience or non-formal training (prior learning): Completion of a process of skills evaluation and accreditation in all the skills units making up the professional certificate.
3. Dual training: Completion of a training and apprenticeship contract, which may range from 1 year (or 6 months, if stipulated as such in the collective agreement) to 3 years, during which effective working time is combined with time dedicated to training under the training programme for the professional certificate.

The training method (number 1 above) requires successful completion of the training modules and the practical training at the workplace:

### Entry/access requirements:

- Compulsory Secondary Education Diploma (Lower secondary education); or
- Professional Certificate Level 1 in the same professional area.
- If neither of the above or higher certifications are held, a pass in the key skills tests.

**Additional information:** Professional certificates are instruments for official accreditation of the professional qualifications in the National Catalogue of Professional Qualifications for all economic activities, within the scope of the labour administration. The National Repertoire of Professional Certificates is divided into three qualification levels (Level 1, Level 2 and Level 3), and by sectors into 26 professional families and 102 professional areas.
