### Professional Certificate Level 2 in IFCM0210 FIRST-LEVEL MAINTENANCE OF RADIO COMMUNICATIONS SYSTEMS (This translation has no legal status)

### **3. PROFILE OF SKILLS AND COMPETENCES**

The holder of this certificate will have acquired the **general competence** to implement local area and metropolitan wireless networks, and to install software, configure and implement the fixed and mobile radio communications equipment, carrying out preventive maintenance and resolving first-level incidents, in accordance with established procedures. This general competence is divided into the following **skills units** (UC):

- Implement and maintain local and metropolitan area wireless networks (UC1210\_2).
- Configure and implement fixed and mobile network radio communications equipments (UC1211\_2).

– Maintain and resolve first-level incidents in fixed and mobile radio communications systems (UC1212\_2).

The professional skills are acquired through the **learning outcomes** defined within the related Training Modules (MF):

- Implementation and maintenance of wireless local and metropolitan area networks (MF1210\_2).
- Configuration and implementation of fixed and mobile network radio communications equipment (MF1211\_2).

– First-level maintenance of fixed and mobile network radio communications equipment (MF1212\_2).

Practical training at the workplace in first-level maintenance of radio communications systems (MP0392)
(See legal basis for all learning outcomes information acquired by the holder of this Certificate in each MF).
As a reference the learning outcomes include in the Practical training at the workplace that complete and reinforce the learning outcomes acquired in the other training modules, are:

- Take part in the implementation and maintenance of local area and metropolitan wireless networks, as well as the configuration and implementation of fixed and mobile radio communication equipment networks and the maintenance and resolution of incidents in the systems, according to the procedures established by the company.
- Take part in the company's working processes, following the rules and instructions established at the workplace.

# 4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THIS CERTIFICATE

The holder of this certificate may work basically in the communications sector, above all in the following types of companies: public bodies and companies in any productive sector that because of their size need to manage radio communications networks; companies that provide installation, maintenance and technical assistance services to radio communications networks; communications operators and companies that provide communications services. The most pertinent occupations and positions are:

- First-level maintenance operator of radio communications equipment.
- First-level maintenance operator of wireless communications equipment.

# 5. OFFICIAL BASIS OF THE CERTIFICATE

Name and status of the national/regional authority providing accreditation/recognition of the certificate The Ministry of Employment and Social Security or the corresponding autonomous regional administration within the scope of its competence, in the name of the King. The certificate is valid throughout Spain.

# 5. OFFICIAL BASIS OF THE CERTIFICATE

# Level of the certificate

The Professional Certificate Level 2 of the National Repertoire of Professional Certificates corresponds to level 3 of the International Standard Classification of Education (ISCED-P 2011).

The European Qualification Framework (EQF) level:

## Grading scale/Pass requirements

The grading scale and pass level of the training modules are expressed on a scale of 0 to 10. The minimum score for a pass is 5 in every training module including a pass in the practical training at the workplace module. The grading system is as follows:

- FAIL: 0 to 4.9
- PASS-SATISFACTORY: 5 to 6.9
- PASS-GOOD: 7 to 8.9
- PASS-EXCELLENT: 9 to 10

# Access to next level of education/training

This Professional Certificate Level 2 gives access to Professional Certificate Level 3 within the same professional area and family.

For validation purposes, the educational authorities will recognise the professional module or modules of the VET diplomas corresponding to the skills units included in the training modules of this certificate.

# Legal basis

Royal Decree 1531/2011 of 31 October, establishing twelve professional certificates in the professional family Information and Communications Technology, which are included in the National Repertoire of Professional Certificates.

Royal Decree 628/2013 of 2 August, establishing four professional certificates in the professional family Information and Communications Technology, which are included in the National Repertoire of Professional Certificates, and updating the professional certificates established as Appendices I, II, III, IV, V, VI, VII, VIII, IX, X, XI and XII of Royal Decree 1531/2011 of 31 October, and as Appendices I, II, III, IV, V and VI of Royal Decree 686/2011 of 13 May.

# 6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

This certificate may be acquired by:

- 1. Training: Completion with a pass grade of the face-to-face or online training programme.
- 2. Recognition of the professional skills acquired through professional experience or non-formal training (prior learning): Completion of a process of skills evaluation and accreditation in all the skills units making up the professional certificate.
- 3. Dual training: Completion of a training and apprenticeship contract, which may range from 1 year (or 6 months, if stipulated as such in the collective agreement) to 3 years, during which effective working time is combined with time dedicated to training under the training programme for the professional certificate.

The training method (number 1 above) requires successful completion of the training modules and the practical training at the workplace:

#### Entry/access requirements:

- Compulsory Secondary Education Diploma (Lower secondary education); or
- Professional Certificate Level 1 in the same professional area.
- If neither of the above or higher certifications are held, a pass in the key skills tests.

**Additional information:** Professional certificates are instruments for official accreditation of the professional qualifications in the National Catalogue of Professional Qualifications for all economic activities, within the scope of the labour administration. The National Repertoire of Professional Certificates is divided into three qualification levels (Level 1, Level 2 and Level 3), and by sectors into 26 professional families and 102 professional areas.
