## 3. PROFILE OF SKILLS AND COMPETENCES

The holder of this certificate will have acquired the **general competence** to install, configure and maintain microcomputing systems for their use, as well as supporting users in handling applications on these systems as part of an organisation's computer support service. This general competence is divided into the following **skills units** (UC):

- Install and configure the system software in microcomputing systems (UC0219\_2).
- Install, configure and verify the elements of the local network according to established procedures (UC0220\_2).
- Install, configure and maintain computer packages for general purposes and specific applications (UC0221\_2).
- Help users utilise general-purpose computing packages and specific applications (UC0222\_2).

The professional skills are acquired through the **learning outcomes** defined within the related Training Modules (MF):

- Installation and configuration of operating systems (MF0219\_2).
- Implementation of the local network elements (MF0220\_2).
- Installation and configuration of computer applications (MF0221\_2).
- Microcomputing applications (MF0222\_2).
- Practical training at the workplace in urban and industrial waste management (MP0066)

As a reference the learning outcomes include in the Practical training at the workplace that complete and reinforce the learning outcomes acquired in the other training modules, are:

- Install and configure the system software according to the protocols and procedures established by the company.
- Take part in the installation, configuration, implementation and maintenance of a local area network in accordance with the procedures established by the company and the instructions received.
- Install, configure and maintain general-purpose computer packages and specific applications, in accordance with the instructions received.
- Assist the use in the use of office and corporate applications.
- Take part in the company's working processes, following the rules and instructions established at the workplace.

## 4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THIS CERTIFICATE

The holder of this certificate may work in the following types of companies: companies organisations of any size that use computer systems for their administration, in any productive sector; companies that supply and distribute computer and communications services; companies dedicated to the sale of microcomputing equipment; companies providing microcomputing technical assistance services; different public administration services, as part of the organisation's IT support. The most pertinent occupations and positions are:

- Microcomputing systems technician.
- Microcomputing equipment installer.
- PC repairer.
- Microcomputing salesperson.
- Technical support worker.
- E-service operator.

The certificate is valid throughout Spain.</p>		
<p style="text-align: center;"><b>Level of the certificate</b></p> <p>The Professional Certificate Level 2 of the National Repertoire of Professional Certificates corresponds to level 3 of the International Standard Classification of Education (ISCED-P 2011).</p> <p>The European Qualification Framework (EQF) level:</p>		
<p style="text-align: center;"><b>Grading scale/Pass requirements</b></p> <p>The grading scale and pass level of the training modules are expressed on a scale of 0 to 10. The minimum score for a pass is 5 in every training module including a pass in the practical training at the workplace module.</p> <p>The grading system is as follows:</p> <ul style="list-style-type: none"> <li>- FAIL: 0 to 4.9</li> <li>- PASS-SATISFACTORY: 5 to 6.9</li> <li>- PASS-GOOD: 7 to 8.9</li> <li>- PASS-EXCELLENT: 9 to 10</li> </ul>		
<p style="text-align: center;"><b>Access to next level of education/training</b></p> <p>This Professional Certificate Level 2 gives access to Professional Certificate Level 3 within the same professional area and family.</p> <p>For validation purposes, the educational authorities will recognise the professional module or modules of the VET diplomas corresponding to the skills units included in the training modules of this certificate.</p>		
<p style="text-align: center;"><b>Legal basis</b></p> <p>Royal Decree 686/2011 of 13 May, establishing six professional certificates in the Information and Communication Technology professional family, which are included in the National Repertoire of Professional Certificates. (Appendix I, Code: IFCT0209)</p> <p>Amended by Royal Decree 628/2013 of 2 August, establishing four professional certificates in the professional family I Information and Communication Technology, which are included in the National Repertoire of Professional Certificates, and updating the professional certificates established as Appendices I, II, III, IV, V, VI, VII, VIII, IX, X, XI and XII of Royal Decree 1531/2011 of 31 October, and as Appendices I, II, III, IV, V and VI of Royal Decree 686/2011 of 13 May.</p>		

<b>6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE</b>		
<p>This certificate may be acquired by:</p> <ol style="list-style-type: none"> <li>1. Training: Completion with a pass grade of the face-to-face or online training programme.</li> <li>2. Recognition of the professional skills acquired through professional experience or non-formal training (prior learning): Completion of a process of skills evaluation and accreditation in all the skills units making up the professional certificate.</li> <li>3. Dual training: Completion of a training and apprenticeship contract, which may range from 1 year (or 6 months, if stipulated as such in the collective agreement) to 3 years, during which effective working time is combined with time dedicated to training under the training programme for the professional certificate.</li> </ol> <p>The training method (number 1 above) requires successful completion of the training modules and the practical training at the workplace:</p>

<p><b>Entry/access requirements:</b></p> <ul style="list-style-type: none"> <li>- Compulsory Secondary Education Diploma (Lower secondary education); or</li> <li>- Professional Certificate Level 1 in the same professional area.</li> <li>- If neither of the above or higher certifications are held, a pass in the key skills tests.</li> </ul> <p><b>Additional information:</b> Professional certificates are instruments for official accreditation of the professional qualifications in the National Catalogue of Professional Qualifications for all economic activities, within the scope of the labour administration. The National Repertoire of Professional Certificates is divided into three qualification levels (Level 1, Level 2 and Level 3), and by sectors into 26 professional families and 102 professional areas.
