## 3. PROFILE OF SKILLS AND COMPETENCES

The holder of this certificate will have acquired the **general competence** apply techniques for face and body hygiene, depilation, make-up and sales techniques for products and services, following precise criteria for management and selection of various beauty techniques under safety, hygiene and disinfection conditions, meeting customer needs and demands. This general competence is divided into the following **skills units** (UC):

- Serve customers of hygiene, depilation and makeup beauty services under safety, health and hygiene conditions (UC0354\_2).
- Apply face and body hygiene and moisturising beauty techniques (UC0355\_2).
- Remove body hair with mechanical procedures and body-hair discolour (UC0345\_1).
- Improve facial harmony with social make-up styles (UC0065\_2).
- Provide advice on and sell personal image products and services (UC0352\_2).

The professional skills are acquired through the **learning outcomes** defined within the related Training Modules (MF):

- Health and safety in hygiene, depilation and makeup beauty services (MF0354\_2).
- Face and body hygiene and moisturising (MF0355\_2).
- Mechanical depilation and body-hair discolouring (MF0345\_1).
- Social make-up (MF0065\_2).
- Advice on and sale of Personal image products and services (MF0352\_2).
- Practical training at the workplace in hygiene, depilation and make-up beauty services (MP0022)

(See legal basis for all learning outcomes information acquired by the holder of this Certificate in each MF).

As a reference the learning outcomes include in the Practical training at the workplace that complete and reinforce the learning outcomes acquired in the other training modules, are:

- Apply beauty service customer care techniques in beauty salons.
- Examine characteristics and condition of customers' skin and its elements to provide hygiene, moisturising and depilation services.
- Prepare and accommodate customers in line with the decolouring, depilation, hygiene or moisturising service requested and under the right safety conditions.
- Select and prepare the necessary tools, cosmetics, products, materials and equipment to perform hygiene, decolouring, depilation and make-up techniques.
- Apply face and body hygiene techniques under safety and hygiene conditions, fulfilling technical requirements and customer conditions.
- Apply face and body moisturising techniques under health and safety conditions, fulfilling technical requirements and customer's conditions.
- Apply appropriate beauty massage for face and body hygiene and moisturising techniques.
- Apply decolouring and mechanical depilation of facial and body hair in line with area characteristics, complying with adequate health and safety measures.
- Apply different styles of social make-up according to beauty characteristics, age, personality and client situation in which it is to be worn and under optimal health and safety conditions.
- Apply adequate techniques for the promotion and sale of personal image products and services.
- Apply personal image customer follow-up procedures and after-sales tracking.
- Assess outcomes and level of customer's satisfaction, proposing corrective measures for any deviations there may be in the hygiene, moisturising, decolouring, mechanical depilation and social make-up services.
- Take part in the company's working processes, following the rules and instructions established at the workplace.

## 4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THIS CERTIFICATE

The holder of this certificate may work in beauty or hairstyling companies as an employee or self-employed, in beauty salons, spas, beauty centres in hotels and hair salons. The holder may also work in the beauty and hairstyling services industry in establishments devoted to selling cosmetics and/or equipment, in the general cosmetics section and for cosmetic brands in shopping centres.

The most pertinent occupations and positions are:

- Makeup artist.
- Hair remover.
- Beautician assistant.
- Cosmetics and beauty services beauty consultant.
- Cosmetics demonstrator.

## 5. OFFICIAL BASIS OF THE CERTIFICATE

### Name and status of the national/regional authority providing accreditation/recognition of the certificate

The Ministry of Employment and Social Security or the corresponding autonomous regional administration within the scope of its competence, in the name of the King. The certificate is valid throughout Spain.

### Level of the certificate

The Professional Certificate Level 2 of the National Repertoire of Professional Certificates corresponds to level 3 of the International Standard Classification of Education (ISCED-P 2011).

The European Qualification Framework (EQF) level:

### Grading scale/Pass requirements

The grading scale and pass level of the training modules are expressed on a scale of 0 to 10. The minimum score for a pass is 5 in every training module including a pass in the practical training at the workplace module.

The grading system is as follows:

- FAIL: 0 to 4.9
- PASS-SATISFACTORY: 5 to 6.9
- PASS-GOOD: 7 to 8.9
- PASS-EXCELLENT: 9 to 10

### Access to next level of education/training

This Professional Certificate Level 2 gives access to Professional Certificate Level 3 within the same professional area and family.

For validation purposes, the educational authorities will recognise the professional module or modules of the VET diplomas corresponding to the skills units included in the training modules of this certificate.

### Legal basis

Royal Decree 1373/2008 of 1 August, establishing three professional certificates in the professional family Personal Image, which are included in the National Repertoire of Professional Certificates. (Appendix II Code: IMPP0208). Amended by Royal Decree 716/2011, of 20 May, establishing five professional certificates in the professional family Personal Image, which are included in the National Repertoire of Professional Certificates, and updating the professional certificates established under Royal Decree 1373/2008, of 1 August, and the professional certificates established under Royal Decree 1379/2009, of 28 August.

## 6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

This certificate may be acquired by:

1. Training: Completion with a pass grade of the face-to-face or online training programme.
2. Recognition of the professional skills acquired through professional experience or non-formal training (prior

learning): Completion of a process of skills evaluation and accreditation in all the skills units making up the professional certificate.

3. Dual training: Completion of a training and apprenticeship contract, which may range from 1 year (or 6 months, if stipulated as such in the collective agreement) to 3 years, during which effective working time is combined with time dedicated to training under the training programme for the professional certificate.

The training method (number 1 above) requires successful completion of the training modules and the practical training at the workplace:

**Entry/access requirements:**

- Compulsory Secondary Education Diploma (Lower secondary education); or
- Professional Certificate Level 1 in the same professional area.
- If neither of the above or higher certifications are held, a pass in the key skills tests.

**Additional information:** Professional certificates are instruments for official accreditation of the professional qualifications in the National Catalogue of Professional Qualifications for all economic activities, within the scope of the labour administration. The National Repertoire of Professional Certificates is divided into three qualification levels (Level 1, Level 2 and Level 3), and by sectors into 26 professional families and 102 professional areas.
