3. PROFILE OF SKILLS AND COMPETENCES

The holder of this certificate will have acquired the **general competence** to plan the installation, compose and fix the furniture carrying out the complementary installations required and check their condition, with any adjustment and finishing operations necessary, in adequate occupational health conditions and applying established quality procedures. This general competence is divided into the following **skills units** (UC):

- Plan the installation, preparing materials, machines and tools (UC0163_2).
- Assemble and fix the furniture and carry out complementary installations (UC0164_2).
- Check the condition of the installation and carry out adjustment and finishing operations (UC0165_2)

The professional skills are acquired through the **learning outcomes** defined within the related Training Modules (MF):

- Furniture installation projects (MF0163_2).
- Furniture Fitting (MF0164_2).
- Adjustment and finishing of furniture installations (MF0165_2).
- Practical training at the workplace in installation of furniture (MP0045)

(See legal basis for all learning outcomes information acquired by the holder of this Certificate in each MF).

As a reference the learning outcomes include in the Practical training at the workplace that complete and reinforce the learning outcomes acquired in the other training modules, are:

- Represent and characterise the space where the furniture installation will be carried out and collect the data required.
- Compose and interpret the installation plans and lists of materials.
- Fix the assembly according to the project specifications and position the fittings.
- Check that the completed installation meets the required characteristics of order and health within the parameters of general cleanliness.
- Apply and specify the rules corresponding to the furniture installation projects.
- Take part in the company's working processes, following the rules and instructions established at the workplace.

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THIS CERTIFICATE

The holder of this certificate may work in companies dedicated to manufacture, sale and installation of furniture, in the manufacturing sectors of furniture and carpentry elements. The most pertinent occupations and positions are:

- Assembler of wood products and similar materials.
- Cabinetmaker and similar worker.
- Assembler of wood or similar furniture.
- Assembler of kitchen furniture.

The certificate is valid throughout Spain.</p>
<p style="text-align: center;">Level of the certificate</p> <p>The Professional Certificate Level 2 of the National Repertoire of Professional Certificates corresponds to level 3 of the International Standard Classification of Education (ISCED-P 2011).</p> <p>The European Qualification Framework (EQF) level:</p>
<p style="text-align: center;">Grading scale/Pass requirements</p> <p>The grading scale and pass level of the training modules are expressed on a scale of 0 to 10. The minimum score for a pass is 5 in every training module including a pass in the practical training at the workplace module.</p> <p>The grading system is as follows:</p> <ul style="list-style-type: none"> - FAIL: 0 to 4.9 - PASS-SATISFACTORY: 5 to 6.9 - PASS-GOOD: 7 to 8.9 - PASS-EXCELLENT: 9 to 10
<p style="text-align: center;">Access to next level of education/training</p> <p>This Professional Certificate Level 2 gives access to Professional Certificate Level 3 within the same professional area and family.</p> <p>For validation purposes, the educational authorities will recognise the professional module or modules of the VET diplomas corresponding to the skills units included in the training modules of this certificate.</p>
<p style="text-align: center;">Legal basis</p> <p>Royal Decree 1968/2008 of 28 November, establishing four professional certificates in the professional family Wood, Furniture and Cork, which are included in the National Repertoire of Professional Certificates.(Appendix II, Code: MAMR0408)</p>

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE		
<p>This certificate may be acquired by:</p> <ol style="list-style-type: none"> 1. Training: Completion with a pass grade of the face-to-face or online training programme. 2. Recognition of the professional skills acquired through professional experience or non-formal training (prior learning): Completion of a process of skills evaluation and accreditation in all the skills units making up the professional certificate. 3. Dual training: Completion of a training and apprenticeship contract, which may range from 1 year (or 6 months, if stipulated as such in the collective agreement) to 3 years, during which effective working time is combined with time dedicated to training under the training programme for the professional certificate. <p>The training method (number 1 above) requires successful completion of the training modules and the practical training at the workplace:</p>

Entry/access requirements:

- Compulsory Secondary Education Diploma (Lower secondary education); or
- Professional Certificate Level 1 in the same professional area.
- If neither of the above or higher certifications are held, a pass in the key skills tests.

Additional information: Professional certificates are instruments for official accreditation of the professional qualifications in the National Catalogue of Professional Qualifications for all economic activities, within the scope of the labour administration. The National Repertoire of Professional Certificates is divided into three qualification levels (Level 1, Level 2 and Level 3), and by sectors into 26 professional families and 102 professional areas.
