Professional Certificate Level 2 in SEAD0211 FIRE PREVENTION AND MAINTENANCE (This translation has no legal status)

3. PROFILE OF SKILLS AND COMPETENCES

The holder of this certificate will have acquired the **general competence** to protect people and property, assess the facilities and maintain the material resources in operation, in accordance with the standards for prevention of risks in situations of fires and emergencies; and if necessary, assist as first responder in accident or emergency situations. This general competence is divided into the following **skills units** (UC):

- Assess the facilities and compliance with the regulations on prevention of fire and emergency situations (UC1747_2).
- Check and maintain in operation the material resources used for prevention of fire and emergency situations (UC1748_2.
- Apply the safety regulations and maintain the physical capacity for professional performance of activities linked to fire and emergency prevention (UC1749_2).

Be a first responder in case of an accident or emergency situation (UC0272_2).

The professional skills are acquired through the **learning outcomes** defined within the related Training Modules (MF):

- Fire and emergency risk prevention regulations and facilities (MF1747_2).
- Maintenance of the material resources for responding to fire and emergencies (MF1748_2).
- Maintenance of the physical capacity to perform the activity and ensure safety (MF1749_2).
- First aid (MF0272_2).
- Practical training at the workplace in Fire prevention and maintenance (MP0489)

(See legal basis for all learning outcomes information acquired by the holder of this Certificate in each MF). As a reference the learning outcomes include in the Practical training at the workplace that complete and reinforce the learning outcomes acquired in the other training modules, are:

- Prepare a Safety and Emergency Plan for a major event with a large public, applying the prevention, safety and protection regulations, defining the elements to be included and preparing the documentation required for its presentation and implementation.
- Carry out an inspection of a venue with a large public attendance, applying the regulations on prevention, safety and protection, and checking all the safety and prevention systems.
- Take part in the company's working processes, following the rules and instructions established at the workplace.

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THIS CERTIFICATE

The holder of this certificate may work in fire-fighting services dedicated to fire prevention and maintenance. The holder may work in public administration services and industrial sectors dedicated to the production, distribution, manufacture and storage of hazardous products and substances. The most pertinent occupations and positions are:

- Firefighter, in general.
- Specialist airport firefighter.
- Public service firefighter.
- Joint local service firefighter.
- Voluntary firefighter
- Private company fire-fighter.

The related occupations have specific requirements established in the regional regulations.

5. OFFICIAL BASIS OF THE CERTIFICATE

Name and status of the national/regional authority providing accreditation/recognition of the certificate The Ministry of Employment and Social Security or the corresponding autonomous regional administration within the scope of its competence, in the name of the King. The certificate is valid throughout Spain.

Level of the certificate

The Professional Certificate Level 2 of the National Repertoire of Professional Certificates corresponds to level 3 of the International Standard Classification of Education (ISCED-P 2011).

The European Qualification Framework (EQF) level:

Grading scale/Pass requirements

The grading scale and pass level of the training modules are expressed on a scale of 0 to 10. The minimum score for a pass is 5 in every training module including a pass in the practical training at the workplace module. The grading system is as follows:

- FAIL: 0 to 4.9
- PASS-SATISFACTORY: 5 to 6.9
- PASS-GOOD: 7 to 8.9
- PASS-EXCELLENT: 9 to 10

Access to next level of education/training

This Professional Certificate Level 2 gives access to Professional Certificate Level 3 within the same professional area and family.

For validation purposes, the educational authorities will recognise the professional module or modules of the VET diplomas corresponding to the skills units included in the training modules of this certificate.

Legal basis

Royal Decree 624/2013 of 2 August, establishing eight professional certificates in the professional family Security and Environment, which are included in the National Repertoire of Professional Certificates and update the professional certificates established in Appendix I of Royal Decree 1377/2011 of 28 August, and in Appendices I and II of Royal Decree 1536/2011 of 31 October. (Appendix II, Code: SEAD0211)





6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

This certificate may be acquired by:

- 1. Training: Completion with a pass grade of the face-to-face or online training programme.
- Recognition of the professional skills acquired through professional experience or non-formal training (prior learning): Completion of a process of skills evaluation and accreditation in all the skills units making up the professional certificate.
- 3. Dual training: Completion of a training and apprenticeship contract, which may range from 1 year (or 6 months, if stipulated as such in the collective agreement) to 3 years, during which effective working time is combined with time dedicated to training under the training programme for the professional certificate.

The training method (number 1 above) requires successful completion of the training modules and the practical training at the workplace:

Entry/access requirements:

- Compulsory Secondary Education Diploma (Lower secondary education); or
- Professional Certificate Level 1 in the same professional area.
- If neither of the above or higher certifications are held, a pass in the key skills tests.

Additional information: Professional certificates are instruments for official accreditation of the professional qualifications in the National Catalogue of Professional Qualifications for all economic activities, within the scope of the labour administration. The National Repertoire of Professional Certificates is divided into three qualification levels (Level 1, Level 2 and Level 3), and by sectors into 26 professional families and 102 professional areas.
