Professional Certificate Level 2 in SEAD0212 SURVEILLANCE, PRIVATE SECURITY AND PROTECTION OF EXPLOSIVES (This translation has no legal status)

3. PROFILE OF SKILLS AND COMPETENCES

The holder of this certificate will have acquired the **general competence** to monitor, and protect people and their property, preventing the commission of crimes and offenses, in a defined environment (place). This general competence is divided into the following **skill units**(UC):

- Monitor and protect property and people preventing the commission of crimes and offenses (UC0080_2).
- Protect the storage, handling and transport of valuable or dangerous products and explosives. (UC0082_2).

The professional skills are acquired through the **learning outcomes** defined within the related Training Modules (MF):

- Surveillance and private security protection (MF0080_2).
- Surveillance, transport and distribution of valuable or dangerous products and explosives (MF0082_2).
- Practical training at the workplace in surveillance, private security and protection of explosives (MP0558).

(See legal basis for all learning outcomes information acquired by the holder of this Certificate in each MF).

As a reference the learning outcomes include in the Practical training at the workplace that complete and reinforce the learning outcomes acquired in the other training modules, are:

- Adapt knowledge to a real working environment.
- Self integrate into work routines of the working team to participate within as a trainee.
- Participate in real or simulated working situations of security and transport of dangerous substances or explosives.
- Participate in the working processes of the company, following the rules and instructions established at the workplace.





4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THIS CERTIFICATE

The holder of this certificate may work in the sectors engaged in the production, distribution, manufacturing and storage of hazardous substances; commercial areas; leisure centers; sports, artistic and cultural shows, conventions and demonstrations; airport, railway and urban transport facilities; Public administration institutions; banks and financial institutions; hospitals and healthcare centers; energy production centers and communications and protection of people who do not have the character of public authorities. The most relevant occupations and work positions are:

- Security guards.
- Security guards of explosives.
- Mine rangers.

The holder of this Professional certificate has recognition of the preliminary compulsory training specified in article 29 of the State Law 5/2014, of April 4th, Private Security. To exercise the occupation of *security guard*, to pass the tests that enable to exercise the calls of the competent body is required, and be in possession of the professional identity card issued by the Directorate General of Police according to Law 5/2014, of April 4th, Private Security and Royal Decree 2364/1994 of December 9th, by which the Regulation of Private Security is approved. To qualify as security *guard of explosives*, to have obtained the authorization as a security guard will be necessary.

5. OFFICIAL BASIS OF THE CERTIFICATE

Name and status of the national/regional authority providing accreditation/recognition of the certificate

The Ministry of Employment and Social Security or the corresponding autonomous regional administration within the scope of its competence, in the name of the King. The certificate is valid throughout Spain.

Level of the certificate

The Professional Certificate Level 2 of the National Repertoire of Professional Certificates corresponds to level 3 of the International Standard Classification of Education (ISCED-P 2011). The European Qualification Framework (EQF) level:

Grading scale/Pass requirements

The grading scale and pass level of the training modules are expressed on a scale of 0 to 10. The minimum score for a pass is 5 in every training module including a pass in the practical training at the workplace module.

The grading system is as follows:

- FAIL: 0 to 4.9
- PASS-SATISFACTORY: 5 to 6.9
- PASS-GOOD: 7 to 8.9
- PASS-EXCELLENT: 9 to 10

Access to next level of education/training

This Professional Certificate Level 2 gives access to Professional Certificate Level 3 within the same professional area and family.

For validation purposes, the educational authorities will recognise the professional module or modules of the VET diplomas corresponding to the skills units included in the training modules of this certificate.

Legal basis

Royal Decree 548/2014 of June 27th, by which five professional certificates of the professional family Security and Environment, included in the National Repertoire of professional certificates are established, and the two professional certificates of the professional family "Computer and communications" established in Royal Decree 1531/2011, of October 31st and Royal Decree 686/2011, of May 13th, modified by Royal Decree 628/2013 of August 2nd are updated. 6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

This certificate may be acquired by:

- 1. Training: Completion with a pass grade of the face-to-face or online training programme.
- Recognition of the professional skills acquired through professional experience or non-formal training (prior learning): Completion of a process of skills evaluation and accreditation in all the skills units making up the professional certificate.
- 3. Dual training: Completion of a training and apprenticeship contract, which may range from 1 year (or 6 months, if stipulated as such in the collective agreement) to 3 years, during which effective working time is combined with time dedicated to training under the training programme for the professional certificate.

The training method (number 1 above) requires successful completion of the training modules and the practical training at the workplace:

Entry/access requirements:

- Compulsory Secondary Education Diploma (Lower secondary education); or
- Professional Certificate Level 1 in the same professional area.
- If neither of the above or higher certifications are held, a pass in the key skills tests.

Additional information: Professional certificates are instruments for official accreditation of the professional qualifications in the National Catalogue of Professional Qualifications for all economic activities, within the scope of the labour administration. The National Repertoire of Professional Certificates is divided into three qualification levels (Level 1, Level 2 and Level 3), and by sectors into 26 professional families and 102 professional areas.
