# **3. PROFILE OF SKILLS AND COMPETENCES**

The holder of this certificate will have acquired the **general competence** to protect, prepare and paint surfaces and carry out maintenance operations on fibreglass components on sports and recreational vessels, applying criteria of quality and complying with the company's occupational risk prevention and environmental plans. This general competence is divided into the following **skills units** (UC):

- Prepare and protect the surfaces of sports and recreational vessels (UC1841\_2).
- Carry out finishing operations on surfaces below the waterline, on the deck, superstructures and spars of sports and recreational vessels (UC1842\_2).
- Repair fibreglass components on sports and recreational vessels (UC1843).
- Construct, adapt and mount fibreglass parts and structures on sports and recreational vessels (UC1844\_2).

The professional skills are acquired through the **learning outcomes** defined within the related Training Modules (MF):

- Preparation and protection of the surfaces of sports and recreational vessels (MF1841\_2).
- Finishing operations on surfaces below the waterline, on deck, superstructures and spars of sports and recreational vessels (MF1842\_2).
- Repair of fibreglass components on sports and recreational vessels (MF1843\_2).
- Construction, adaptation and mounting of fibreglass parts and structures on sports and recreational vessels (MF1844\_2).
- Practical training at the workplace in painting, repair and construction of fibreglass components on sports and recreational vessels (MP0474)

(See legal basis for all learning outcomes information acquired by the holder of this Certificate in each MF). As a reference the learning outcomes include in the Practical training at the workplace that complete and reinforce the learning outcomes acquired in the other training modules, are:

- Collaborate on the painting and varnishing work on board, in accordance with the instructions received, and respecting the safety and quality rules established by the company.
- Collaborate on the fibreglass repair work on board in accordance with the instructions received, and respecting the safety and quality rules established by the company.
- Take part in the company's working processes, following the rules and instructions established at the workplace.

# 4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THIS CERTIFICATE

The holder of this certificate may work in the naval sector, in construction of recreational and sports vessels, and naval repair and maintenance.

The most pertinent occupations and positions are:

- Painter of metal structures and boat hulls.
- Paint finisher/varnish painter of wood furniture.
- Paint finisher / varnish painter of wood fittings.
- Painter of sports and recreational vessels.
- Specialist in the maintenance of fibreglass components.
- Specialist in the manufacturing process of fibreglass components.

The holder of this professional certificate has recognition of the basic level training in labour risk prevention, according to Annex IV of the Royal Decree 39/1997 of 17 of January approving the Labour Risks Prevention Act.

# **5. OFFICIAL BASIS OF THE CERTIFICATE**

Name and status of the national/regional authority providing accreditation/recognition of the certificate The Ministry of Employment and Social Security or the corresponding autonomous regional administration within the scope of its competence, in the name of the King. The certificate is valid throughout Spain.

#### Level of the certificate

The Professional Certificate Level 2 of the National Repertoire of Professional Certificates corresponds to level 3 of the International Standard Classification of Education (ISCED-P 2011).

The European Qualification Framework (EQF) level:

#### Grading scale/Pass requirements

The grading scale and pass level of the training modules are expressed on a scale of 0 to 10. The minimum score for a pass is 5 in every training module including a pass in the practical training at the workplace module. The grading system is as follows:

- FAIL: 0 to 4.9
- PASS-SATISFACTORY: 5 to 6.9
- PASS-GOOD: 7 to 8.9
- PASS-EXCELLENT: 9 to 10

#### Access to next level of education/training

This Professional Certificate Level 2 gives access to Professional Certificate Level 3 within the same professional area and family.

For validation purposes, the educational authorities will recognise the professional module or modules of the VET diplomas corresponding to the skills units included in the training modules of this certificate.

#### Legal basis

Royal Decree 626/2013 of 2 August, establishing six professional certificates in the professional family Transport and Vehicle Maintenance, which are included in the National Repertoire of Professional Certificates, and updating the professional certificates established as Appendix V of Royal Decree 723/2011 of 20 May, and as Appendix V of Royal Decree 1539/2011 of 31 October. # 6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

This certificate may be acquired by:

- 1. Training: Completion with a pass grade of the face-to-face or online training programme.
- Recognition of the professional skills acquired through professional experience or non-formal training (prior learning): Completion of a process of skills evaluation and accreditation in all the skills units making up the professional certificate.
- 3. Dual training: Completion of a training and apprenticeship contract, which may range from 1 year (or 6 months, if stipulated as such in the collective agreement) to 3 years, during which effective working time is combined with time dedicated to training under the training programme for the professional certificate.

The training method (number 1 above) requires successful completion of the training modules and the practical training at the workplace:

# Entry/access requirements:

- Compulsory Secondary Education Diploma (Lower secondary education); or
- Professional Certificate Level 1 in the same professional area.
- If neither of the above or higher certifications are held, a pass in the key skills tests.

**Additional information:** Professional certificates are instruments for official accreditation of the professional qualifications in the National Catalogue of Professional Qualifications for all economic activities, within the scope of the labour administration. The National Repertoire of Professional Certificates is divided into three qualification levels (Level 1, Level 2 and Level 3), and by sectors into 26 professional families and 102 professional areas.
