3. PROFILE OF SKILLS AND COMPETENCES

The holder of this certificate will have acquired the **general competence** to manage the livestock production operation, scheduling and organizing the material and human resources available and the work required, applying criteria of economic profitability and satisfying environmental regulations, quality control criteria, health and animal welfare regulations, food safety and occupational risks prevention measures. This general competence is divided into the following **skill units** (UC):

- Manage the processes of production of renewing animals, breeding animals and offspring, and lactating animals (UC1495_3).
- Manage the processes of production of rearing and fattening animals (UC1496_3).
- Manage the processes of production of poultry and eggs (UC1497_3).
- Manage facilities, machinery, materials and equipment in the animals farm (UC0536_3).

The professional skills are acquired through the **learning outcomes** defined within the related Training Modules (MF):

- Management of production processes of renewing animals, breeding animals and offspring, and dairy animals (MF1495_3).
- Management of production processes animal rearing and fattening (MF1496_3).
- Management of production processes of poultry and eggs (MF1497_3).
- Management of facilities, machinery, materials and equipment of the animal farm (MF0536_3).
- Practical training at the workplace in management of livestock production (MP0450).

As a reference the learning outcomes include in the Practical training at the workplace that complete and reinforce the learning outcomes acquired in the other training modules, are:

- Cooperate in the management of production processes of renewing animals, breeding animals and their offspring animals.
- Participate in the management of production processes of rearing and fattening animals.
- Participate in the management of production processes of poultry and eggs.
- Participate in the working processes of the company, following the rules and instructions established at the workplace.

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THIS CERTIFICATE

The holder of this certificate may work in the agricultural sector, in the following activities: animal farms of any type; institutions of research and experimentation in livestock production and companies dedicated to livestock services.

The most relevant occupations and work positions are:

- Managers or foremen of livestock in general.
- Responsible of production in cooperatives, agricultural processing companies and other associations of farmers.
- Responsible for the production on farms or livestock enterprises.
- Responsible companies related to livestock production services.
- Responsible for artificial insemination in livestock farms or semen collection centers.
- Responsible for machinery and livestock equipment.

5. OFFICIAL BASIS OF THE CERTIFICATE

Name and status of the national/regional authority providing accreditation/recognition of the certificate

The Ministry of Employment and Social Security or the corresponding autonomous regional administration within the scope of its competence, in the name of the King. The certificate is valid throughout Spain.

Level of the certificate

The Professional Certificate Level 3 of the National Repertoire of Professional Certificates corresponds to level 4 of the International Standard Classification of Education (ISCED-P 2011).

The European Qualification Framework (EQF) level:

Grading scale/Pass requirements

The grading scale and pass level of the training modules are expressed on a scale of 0 to 10. The minimum score for a pass is 5 in every training module including a pass in the practical training at the workplace module.

The grading system is as follows:

- FAIL: 0 to 4.9
- PASS-SATISFACTORY: 5 to 6.9
- PASS-GOOD: 7 to 8.9
- PASS-EXCELLENT: 9 to 10

Access to next level of education/training

This Professional Certificate Level 3 gives access to Professional Certificate Level 3 within the same professional area and family.

For validation purposes, the educational authorities will recognise the professional module or modules of the VET diplomas corresponding to the skills units included in the training modules of this certificate.

Legal basis

Royal Decree 627/2013 of August 2nd, by which seven professional certificates of the Professional Family of Agriculture, included in the National Repertoire of professional certificates are established, and the professional certificates established as Appendix II, III and IV of Royal Decree 1211/2009, of July 17th as amended by Royal Decree 682/2011, of May 13th as Appendix V and VI of Royal Decree 682/2011, of May 13th are updated. (Appendix IV, Code: AGAN0311)

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

This certificate may be acquired by:

1. Training: Completion with a pass grade of the face-to-face or online training programme.
2. Recognition of the professional skills acquired through professional experience or non-formal training (prior learning): Completion of a process of skills evaluation and accreditation in all the skills units making up the professional certificate.
3. Dual training: Completion of a training and apprenticeship contract, which may range from 1 year (or 6 months, if stipulated as such in the collective agreement) to 3 years, during which effective working time is combined with time dedicated to training under the training programme for the professional certificate.

The training method (number 1 above) requires successful completion of the training modules and the practical training at the workplace:

Entry/access requirements:

- *Bachiller* Diploma (upper secondary education); or
- Professional Certificate Level 2 in the same professional area.
- If neither of the above or higher certifications are held, a pass in the key skills tests.

Additional information: Professional certificates are instruments for official accreditation of the professional qualifications in the National Catalogue of Professional Qualifications for all economic activities, within the scope of the labour administration. The National Repertoire of Professional Certificates is divided into three qualification levels (Level 1, Level 2 and Level 3), and by sectors into 26 professional families and 102 professional areas.
