3. PROFILE OF SKILLS AND COMPETENCES

The holder of this certificate will have acquired the **general competence** to program and organise the activities required for forestry restocking, water and forestry regulation and forestry work in general, as well as coordinating the human and material resources available, while complying with the regulations on occupational risk prevention and respecting the natural environment. This general competence is divided into the following **skills units** (UC):

- Carry out surveying operations in agriculture, gardening and woodland work (UC0727_3).
- Manage the operations of forestry restocking and water and forestry control (UC0728_3).
- Manage forestry work (UC0729_3).
- Manage the machinery, equipment and installations used in forestry work (UC0730)

The professional skills are acquired through the **learning outcomes** defined within the related Training Modules (MF):

- Surveying operations in agriculture, gardening and woodland work (MF0727_3).
- Management of forest restocking and water and forest control (MF0728_3).
- Management of forestry work (MF0729_3).
- Management of the machinery, equipment and installations used in forestry work (MF0730_3).
- Practical training at the workplace in management of restocking and forestry work (MP0145)

(See legal basis for all learning outcomes information acquired by the holder of this Certificate in each MF).

As a reference the learning outcomes include in the Practical training at the workplace that complete and reinforce the learning outcomes acquired in the other training modules, are:

- Carry out surveying work, simple levelling and restocking using topographical equipment and resources and the most appropriate method in each case.
- Organise and supervise the work needed for the restocking project or the water and forestry control.
- Organise and control the construction work and/or maintenance of a forest trail.
- Program and control the forestry work to be carried out in a forest stand.
- Program and control the work on preventing forest fires.
- Control the state and operating conditions of the machinery, equipment and forest installations, as well as their use.
- Organise a workshop for the maintenance and repair of machinery, equipment and forestry installations and coordinate its operation.
- Take part in the company's working processes, following the rules and instructions established at the workplace.

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THIS CERTIFICATE

The holder of this certificate may work in the agricultural sector, within the forestry sub-sector, in the following productive activities: Forest restocking companies; companies that carry out water and forestry control work; companies that carry out forestry work; and Companies that carry out construction and maintenance work on forest trails. The most pertinent occupations and positions are:

- Restocking company supervisor.
- Supervisor in companies that carry out water and forestry control work.
- Supervisor in companies that carry out forestry work.
- Supervisor in companies that carry out work fighting forest pests and diseases.
- Supervisor in companies that carry out construction and maintenance work on forest trails.
- Qualified self-employed worker in restocking, forestry work and treatment against pests and forest diseases.
- Practice in topographic work.
- Specialist in treatment with pesticides and/or herbicides.
- Forestry and/or silviculture specialist.
- Forestry agent.

Requirements to exercise the profession:

The training included under this Royal Decree in the training module of management of forestry work guarantees the level of knowledge needed to carry out pesticide treatment at a qualified level, in accordance with the demands of Royal Decree 3349/1983 of 30 November, approving the technical and health Regulation for the manufacture, sale and use of pesticides, the applicators and the staff of companies dedicated to pesticide treatment, and Order PRE/2922/2005 of 19 September 2005, modifying the Order of 8 March 1994, establishing the regulations approving the courses offering qualifications to carry out treatment with pesticides.

5. OFFICIAL BASIS OF THE CERTIFICATE

Name and status of the national/regional authority providing accreditation/recognition of the certificate

The Ministry of Employment and Social Security or the corresponding autonomous regional administration within the scope of its competence, in the name of the King. The certificate is valid throughout Spain.

Level of the certificate

The Professional Certificate Level 3 of the National Repertoire of Professional Certificates corresponds to level 4 of the International Standard Classification of Education (ISCED-P 2011).

The European Qualification Framework (EQF) level:

Grading scale/Pass requirements

The grading scale and pass level of the training modules are expressed on a scale of 0 to 10. The minimum score for a pass is 5 in every training module including a pass in the practical training at the workplace module.

The grading system is as follows:

- FAIL: 0 to 4.9
- PASS-SATISFACTORY: 5 to 6.9
- PASS-GOOD: 7 to 8.9
- PASS-EXCELLENT: 9 to 10

Access to next level of education/training

This Professional Certificate Level 3 gives access to Professional Certificate Level 3 within the same professional area and family.

For validation purposes, the educational authorities will recognise the professional module or modules of the VET diplomas corresponding to the skills units included in the training modules of this certificate.

Legal basis

Royal Decree 682/2011 of 13 May, establishing six professional certificates in the professional family Agriculture, which are included in the National Repertoire of Professional Certificates, and updating the professional certificates established as Appendices I, II, IV, VI, VII, VIII and XII of Royal Decree 1375/2008 of 1 August, the professional certificate established as Appendix I of Royal Decree 1965/2008 of 28 November, and the professional certificate established as Appendix III of Royal Decree 1211/2009 of 17 July. 5. OFFICIAL BASIS OF THE CERTIFICATE

Amended by Royal Decree 627/2013 of 2 August, establishing seven professional certificates in the professional family Agriculture, which are included in the National Repertoire of Professional Certificates, and updating the professional certificates established as Appendices II, III and IV of Royal Decree 1211/2009 of 17 July, amended by Royal Decree 2682/2011 of 13 May and as Appendices V and VI of Royal Decree 682/2011 of 13 May.

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

This certificate may be acquired by:

1. Training: Completion with a pass grade of the face-to-face or online training programme.
2. Recognition of the professional skills acquired through professional experience or non-formal training (prior learning): Completion of a process of skills evaluation and accreditation in all the skills units making up the professional certificate.
3. Dual training: Completion of a training and apprenticeship contract, which may range from 1 year (or 6 months, if stipulated as such in the collective agreement) to 3 years, during which effective working time is combined with time dedicated to training under the training programme for the professional certificate.

The training method (number 1 above) requires successful completion of the training modules and the practical training at the workplace:

Entry/access requirements:

- *Bachiller* Diploma (upper secondary education); or
- Professional Certificate Level 2 in the same professional area.
- If neither of the above or higher certifications are held, a pass in the key skills tests.

Additional information: Professional certificates are instruments for official accreditation of the professional qualifications in the National Catalogue of Professional Qualifications for all economic activities, within the scope of the labour administration. The National Repertoire of Professional Certificates is divided into three qualification levels (Level 1, Level 2 and Level 3), and by sectors into 26 professional families and 102 professional areas.
