#### **3. PROFILE OF SKILLS AND COMPETENCES**

The holder of this certificate will have acquired the **general competence** to organise and supervise the activities needed for logging, managing the material and human resources available, applying criteria of quality, profitability and environmental sustainability, minimising the impact on the environment and respecting current law, particularly environmental and occupational risk prevention regulations. This general competence is divided into the following skills units (UC):

- Organise and supervise the inventory and monitoring operations of the natural habitat (UC1486\_3).
- Manage logging operations (UC1487\_3).
- Manage non-logging forestry work (UC1488\_3).
- Manage the machinery, equipment and installations used in forestry work (UC0730\_3).

The professional skills are acquired through the **learning outcomes** defined within the related Training Modules (MF):

- Organisation and supervision of the operations of inventory and monitoring of the natural habitat (MF1486\_3).
- Management of logging operations (MF1487\_3).
- Management of non-logging forestry work (MF1488\_3).
- Management of the machinery, equipment and installations used in forestry work (MF0730\_3).
- Practical training at the workplace in Management of logging operations (MP0363)
- (See legal basis for all learning outcomes information acquired by the holder of this Certificate in each MF).

As a reference the learning outcomes include in the Practical training at the workplace that complete and reinforce the learning outcomes acquired in the other training modules, are:

- Organise work on a census of animals.
- Organise the inventory of vegetation.
- Organise the work of felling, processing and grouping of timber.
- Program the work of clearing wood products and processing of the by-products obtained.
- Control the state and operating conditions of the machinery, equipment and forest installations, as well as their use.
- Organise a workshop for the maintenance and repair of machinery, equipment and forestry installations and coordinate its operation.
- Take part in the company's working processes, following the rules and instructions established at the workplace.

#### 4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THIS CERTIFICATE

The holder of this certificate may work in the agricultural sector, within the forestry sub-sector, in the following productive activities: Logging operations. Companies carrying out logging operations. The most pertinent occupations and positions are:

- Forestry technician.
- Forester or forestry worker.
- Supervisor in a logging company.

# **5. OFFICIAL BASIS OF THE CERTIFICATE**

Name and status of the national/regional authority providing accreditation/recognition of the certificate The Ministry of Employment and Social Security or the corresponding autonomous regional administration within the scope of its competence, in the name of the King. The certificate is valid throughout Spain.

## Level of the certificate

The Professional Certificate Level 3 of the National Repertoire of Professional Certificates corresponds to level 4 of the International Standard Classification of Education (ISCED-P 2011).

# Grading scale/Pass requirements

The grading scale and pass level of the training modules are expressed on a scale of 0 to 10. The minimum score for a pass is 5 in every training module including a pass in the practical training at the workplace module.

The grading system is as follows:

- FAIL: 0 to 4.9
- PASS-SATISFACTORY: 5 to 6.9
- PASS-GOOD: 7 to 8.9
- PASS-EXCELLENT: 9 to 10

## Access to next level of education/training

This Professional Certificate Level 3 gives access to Professional Certificate Level 3 within the same professional area and family.

For validation purposes, the educational authorities will recognise the professional module or modules of the VET diplomas corresponding to the skills units included in the training modules of this certificate.

#### Legal basis

Royal Decree 1519/2011 of 31 October, establishing seven professional certificates in the professional family Agriculture, which are included in the National Repertoire of Professional Certificates. (Appendix VII, Code: AGAR0110)

# 6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

This certificate may be acquired by:

- 1. Training: Completion with a pass grade of the face-to-face or online training programme.
- Recognition of the professional skills acquired through professional experience or non-formal training (prior learning): Completion of a process of skills evaluation and accreditation in all the skills units making up the professional certificate.
- 3. Dual training: Completion of a training and apprenticeship contract, which may range from 1 year (or 6 months, if stipulated as such in the collective agreement) to 3 years, during which effective working time is combined with time dedicated to training under the training programme for the professional certificate.

The training method (number 1 above) requires successful completion of the training modules and the practical training at the workplace:

Entry/access requirements:

- Bachiller Diploma (upper secondary education); or
- Professional Certificate Level 2 in the same professional area.
- If neither of the above or higher certifications are held, a pass in the key skills tests.

**Additional information:** Professional certificates are instruments for official accreditation of the professional qualifications in the National Catalogue of Professional Qualifications for all economic activities, within the scope of the labour administration. The National Repertoire of Professional Certificates is divided into three qualification levels (Level 1, Level 2 and Level 3), and by sectors into 26 professional families and 102 professional areas.
