3. PROFILE OF SKILLS AND COMPETENCES

The holder of this certificate will have acquired the **general competence** to develop multimedia products based on publishing projects, designed for the Internet or digital formats; determine aspects of functionality, interaction and usability, defining their architecture, carrying out the design of the graphic and multimedia elements needed to obtain the product, managing and controlling the quality of the multimedia publishing product. This general competence is divided into the following **skills units** (UC):

- Determine the specifications of multimedia publishing projects (UC0935_3).
- Design the multimedia publishing product (UC0936_3).
- Generate and publish multimedia publishing products (UC0937_3).
- Manage and control the quality of the multimedia publishing product (UC0938_3).

The professional skills are acquired through the **learning outcomes** defined within the related Training Modules (MF):

- Projects for multimedia publishing products (MF0935_3).
- Design for multimedia publishing products (MF0936_3).
- Implementation and publication of multimedia publishing products (MF0937_3).
- Management of the quality of multimedia publishing products (MF0938_3).
- Practical training at the workplace in multimedia publishing products (MP0341)

As a reference the learning outcomes include in the Practical training at the workplace that complete and reinforce the learning outcomes acquired in the other training modules, are:

- Collaborate on the product definition in multimedia publishing projects.
- Carry out the graphic design and establish the functionality of the multimedia publishing product based on its specifications document.
- Prepare prototypes of multimedia publishing products integrating multimedia elements and interactivity, in accordance with the functionality document.
- Participate in the process of publishing multimedia products on websites or in digital formats.
- Participate in the process of quality control of multimedia publishing products.
- Take part in the company's working processes, following the rules and instructions established at the workplace.

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THIS CERTIFICATE

The holder of this certificate may work in publishing companies, the press, educational and training companies, the media, advertising agencies, multimedia publication consultancies, communication departments within organisations, companies with a major presence on the Internet, and digital publication departments in publishing companies. The holder may work in the publishing, graphic arts or any other productive sector with sections or departments in which multimedia publishing products are developed. The most pertinent occupations and positions are:

- Multimedia design technician.
- Multimedia publishing project technician.
- Multimedia production technician.
- Multimedia publishing product designer.
- Multimedia publication consultancy assistant.
- Multimedia project layout designer.

<p style="text-align: center;">Grading scale/Pass requirements</p> <p>The grading scale and pass level of the training modules are expressed on a scale of 0 to 10. The minimum score for a pass is 5 in every training module including a pass in the practical training at the workplace module.</p> <p>The grading system is as follows:</p> <ul style="list-style-type: none"> - FAIL: 0 to 4.9 - PASS-SATISFACTORY: 5 to 6.9 - PASS-GOOD: 7 to 8.9 - PASS-EXCELLENT: 9 to 10

<p style="text-align: center;">Legal basis</p> <p>Royal Decree 1520/2011 of 31 October, establishing ten professional certificates in the professional family Graphic Arts, which are included in the National Repertoire of Professional Certificates. (Appendix IX, Code: ARGN0110)</p>	

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE		
<p>This certificate may be acquired by:</p> <ol style="list-style-type: none"> 1. Training: Completion with a pass grade of the face-to-face or online training programme. 2. Recognition of the professional skills acquired through professional experience or non-formal training (prior learning): Completion of a process of skills evaluation and accreditation in all the skills units making up the professional certificate. 3. Dual training: Completion of a training and apprenticeship contract, which may range from 1 year (or 6 months, if stipulated as such in the collective agreement) to 3 years, during which effective working time is combined with time dedicated to training under the training programme for the professional certificate. <p>The training method (number 1 above) requires successful completion of the training modules and the practical training at the workplace:</p>

Entry/access requirements:

- *Bachiller* Diploma (upper secondary education); or
- Professional Certificate Level 2 in the same professional area.
- If neither of the above or higher certifications are held, a pass in the key skills tests.

Additional information: Professional certificates are instruments for official accreditation of the professional qualifications in the National Catalogue of Professional Qualifications for all economic activities, within the scope of the labour administration. The National Repertoire of Professional Certificates is divided into three qualification levels (Level 1, Level 2 and Level 3), and by sectors into 26 professional families and 102 professional areas.
