Professional Certificate Level 3 in FMEM0311 DIES MANUFACTURING FOR SHEET METAL PIECES PRODUCTION (This translation has no legal status)

3. PROFILE OF SKILLS AND COMPETENCES

The holder of this certificate will have acquired the **general competence** to design and manufacture dies for the production of sheet metal pieces, as well as adjusting, mounting and checking their operation, preparing their components based on the technical specifications of the metal piece to be manufactured, planning production, controlling processes and manufactured products, meeting quality criteria, and complying with the company's occupational risk prevention and environmental plans and current law. This general competence is divided into the following **skills units** (UC):

- Design dies to obtain sheet metal pieces (UC2155_3).
- Plan the manufacture of dies to obtain sheet metal pieces (UC2156_3).
- Prepare the components of dies to obtain sheet metal pieces (UC2157_3).
- Adjust, mount and check the function of the die components (UC2158_3).

The professional skills are acquired through the **learning outcomes** defined within the related Training Modules (MF): – Design of dies to obtain sheet metal pieces (MF2155 3).

- Planning of the manufacture of dies to obtain sheet metal pieces (MF2156_3).
- Preparation of the components of dies to obtain sheet metal pieces (MF2157 3).
- Adjustment, mounting and checking of the function of the die components (MF2158_3).
- Practical training at the workplace in dies manufacturing for sheet metal pieces production (MP0449)

As a reference the learning outcomes include in the Practical training at the workplace that complete and reinforce the learning outcomes acquired in the other training modules, are:

- Design of dies, defining their form, dimensions, construction solutions and cost.
- Prepare programs for manufacturing dies and their mounting based on technical documentation, according to available resources.
- Mechanise the components of dies, preparing and manipulating lathes, machining centres, grinding and electrical discharge machines.
- Carry out adjustments, mounting and tests of the dies according to the design specifications, complying with occupational risk prevention and environmental protection standards.
- Take part in the company's working processes, following the rules and instructions established at the workplace.

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THIS CERTIFICATE

The holder of this certificate may work in the areas of planning and production in companies dedicated to the design, construction, adjustment and mounting of dies for the production of sheet metal pieces. The holder may work in the subsector of the metal transforming industry, above all in the following economic activities: metallurgy; manufacture of metal products; and manufacture using dies. The most pertinent occupations and positions are:

- Project draughtsman for dies used in sheet metal processing.
- Die fitter for sheet metal processing.
- Die manufacturing supervisor.
- Die production programmer.
- Technical industrial designer.
- Die and moulding technician.
- Metal die and moulding operator.





4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THIS CERTIFICATE

- Machine tool fitter with CNC for working with metals.

5. OFFICIAL BASIS OF THE CERTIFICATE

Name and status of the national/regional authority providing accreditation/recognition of the certificate The Ministry of Employment and Social Security or the corresponding autonomous regional administration within the scope of its competence, in the name of the King. The certificate is valid throughout Spain.

Level of the certificate

The Professional Certificate Level 3 of the National Repertoire of Professional Certificates corresponds to level 4 of the International Standard Classification of Education (ISCED-P 2011).

The European Qualification Framework (EQF) level:

Grading scale/Pass requirements

The grading scale and pass level of the training modules are expressed on a scale of 0 to 10. The minimum score for a pass is 5 in every training module including a pass in the practical training at the workplace module. The grading system is as follows:

- FAIL: 0 to 4.9
- PASS-SATISFACTORY: 5 to 6.9
- PASS-GOOD: 7 to 8.9
- PASS-EXCELLENT: 9 to 10

Access to next level of education/training

This Professional Certificate Level 3 gives access to Professional Certificate Level 3 within the same professional area and family.

For validation purposes, the educational authorities will recognise the professional module or modules of the VET diplomas corresponding to the skills units included in the training modules of this certificate.

Legal basis

Royal Decree 618/2013 of 2 August, establishing four professional certificates in the professional family Metal working, which are included in the National Repertoire of Professional Certificates and update the professional certificates established in Appendices I and II of Royal Decree 1521/2011 of 31 October. (Appendix III, Code: FMEM0311)

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

This certificate may be acquired by:

- 1. Training: Completion with a pass grade of the face-to-face or online training programme.
- Recognition of the professional skills acquired through professional experience or non-formal training (prior learning): Completion of a process of skills evaluation and accreditation in all the skills units making up the professional certificate.
- 3. Dual training: Completion of a training and apprenticeship contract, which may range from 1 year (or 6 months, if stipulated as such in the collective agreement) to 3 years, during which effective working time is combined with time dedicated to training under the training programme for the professional certificate.

The training method (number 1 above) requires successful completion of the training modules and the practical training at the workplace:

Entry/access requirements:

- Bachiller Diploma (upper secondary education); or
- Professional Certificate Level 2 in the same professional area.
- If neither of the above or higher certifications are held, a pass in the key skills tests.

Additional information: Professional certificates are instruments for official accreditation of the professional qualifications in the National Catalogue of Professional Qualifications for all economic activities, within the scope of the labour administration. The National Repertoire of Professional Certificates is divided into three qualification levels (Level 1, Level 2 and Level 3), and by sectors into 26 professional families and 102 professional areas.
