3. PROFILE OF SKILLS AND COMPETENCES

The holder of this certificate will have acquired the **general competence** to develop restoration projects in natural stone, based on the identification of damage, proposing the restoration work to be carried out, preparing the technical documentation for the project and planning and supervising the execution, either independently or based on instructions and/or documentation prepared by higher-level technicians. In those assets declared of cultural interest by the competent government authority, the work must comply with regulations governing protection. This general competence is divided into the following **skills units** (UC):

- Assess damage and define proposals for restoration work in natural stone (UC1391_3).
- Develop technical projects for restoration work in natural stone and program their execution (UC1392_3).
- Coordinate and supervise the execution of restoration projects for work in natural stone (UC1393_3).

The professional skills are acquired through the **learning outcomes** defined within the related Training Modules (MF):

- Assess the damage and define proposals for restoration work in natural stone (MF1391_3).
- Development and preparation of technical restoration projects in natural stone (MF1392_3).
- Coordination and supervision of restoration projects in natural stone (MF1393_3).
- Practical training at the workplace in the development and supervision of restoration work in natural stone (MPO221)

(See legal basis for all learning outcomes information acquired by the holder of this Certificate in each MF).

As a reference the learning outcomes include in the Practical training at the workplace that complete and reinforce the learning outcomes acquired in the other training modules, are:

- Take part in the identification of damage and the preparation of the report on damage and proposals for restoration, following the procedures established by the company.
- Take part in the preparation of restoration projects for natural stone elements and sets, defining the different work to be carried out, the techniques and methods to use, and the material and human resources required.
- Prepare budgets for restoration projects, identifying the units of work and measuring and calculating partial and total unit prices.
- Take part in the preparation and implementation of quality, safety and environmental protection plans in restoration work with natural stone, following the procedures established by the company.
- Organise the human and material resources in the natural stone restoration work, in order to optimise times and results, following the procedures established by the company.
- Prepare the certifications and partial and final reports on natural stone restoration work, based on the documentation and monitoring and control of the work.
- Take part in the company's working processes, following the rules and instructions established at the workplace.

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THIS CERTIFICATE

The holder of this certificate may work in companies dedicated to the rehabilitation or restoration of work in natural stone, or integrated in construction or civil works companies. The holder may work in the conservation of historic locations and urban areas; the restoration and rehabilitation of construction work in natural stone; or the restoration of natural stone elements and ornamental groups.

The most pertinent occupations and positions are:

- Manager of rehabilitation and restoration work in natural stone.
- Natural stone restoration specialist.

5. OFFICIAL BASIS OF THE CERTIFICATE

Name and status of the national/regional authority providing accreditation/recognition of the certificate

The Ministry of Employment and Social Security or the corresponding autonomous regional administration within the scope of its competence, in the name of the King. The certificate is valid throughout Spain.

Level of the certificate

The Professional Certificate Level 3 of the National Repertoire of Professional Certificates corresponds to level 4 of the International Standard Classification of Education (ISCED-P 2011).

The European Qualification Framework (EQF) level:

Grading scale/Pass requirements

The grading scale and pass level of the training modules are expressed on a scale of 0 to 10. The minimum score for a pass is 5 in every training module including a pass in the practical training at the workplace module.

The grading system is as follows:

- FAIL: 0 to 4.9
- PASS-SATISFACTORY: 5 to 6.9
- PASS-GOOD: 7 to 8.9
- PASS-EXCELLENT: 9 to 10

Access to next level of education/training

This Professional Certificate Level 3 gives access to Professional Certificate Level 3 within the same professional area and family.

For validation purposes, the educational authorities will recognise the professional module or modules of the VET diplomas corresponding to the skills units included in the training modules of this certificate.

Legal basis

Royal Decree 713/2011 of 20 May, establishing twelve professional certificates in the professional family Extraction Industry, which are included in the National Repertoire of Professional Certificates, and updating the professional certificates established in Royal Decree 1217/2009 of 17 July. (Appendix I, Code: IEXD0309)

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

This certificate may be acquired by:

1. Training: Completion with a pass grade of the face-to-face or online training programme.
2. Recognition of the professional skills acquired through professional experience or non-formal training (prior learning): Completion of a process of skills evaluation and accreditation in all the skills units making up the professional certificate.
3. Dual training: Completion of a training and apprenticeship contract, which may range from 1 year (or 6 months, if stipulated as such in the collective agreement) to 3 years, during which effective working time is combined with time dedicated to training under the training programme for the professional certificate.

The training method (number 1 above) requires successful completion of the training modules and the practical training at the workplace:
