#### 3. PROFILE OF SKILLS AND COMPETENCES

The holder of this certificate will have acquired the **general competence** to supervise and control the assembly of fluid distribution networks and systems, controlling their set-up according to an execution project, as well as planning, managing or carrying out maintenance, in accordance with the laws and regulations established and the planned quality level, guaranteeing the comprehensive safety and security of the installation and the prevention of occupational and environmental risks. This general competence is divided into the following **skills units** (UC):

- Supervise and control the assembly of fluid distribution networks and systems (UC1286\_3).
- Plan the maintenance of fluid distribution networks and systems (UC1287\_3).
- Carry out and supervise the maintenance of fluid distribution networks and systems (UC1288 3).
- Control and start up the fluid distribution networks and systems (UC1289\_3).

The professional skills are acquired through the learning outcomes defined within the related Training Modules (MF):

- Assembly processes for fluid distribution networks and systems (MF1286\_3).
- Organisation of the maintenance of fluid distribution networks and systems (MF1287\_3).
- Supervision and maintenance of fluid distribution networks and systems (MF1288\_3).
- Start-up of fluid distribution networks and systems (MF1289\_3).
- Practical training at the workplace in the planning, management, maintenance and supervision of fluid distribution networks and systems assembly (MP0132)

(See legal basis for all learning outcomes information acquired by the holder of this Certificate in each MF).

As a reference the learning outcomes include in the Practical training at the workplace that complete and reinforce the learning outcomes acquired in the other training modules, are:

- Describe the procedure for machining and assembling a fluid distribution network.
- Implement a preventive maintenance plan for a fluid distribution system, using the required technical documentation.
- Plan a maintenance intervention involving the repair, replacement and start-up of a fluid distribution system, using the corresponding technical documentation available.
- Take part in the company's working processes, following the rules and instructions established at the workplace.

#### 4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THIS CERTIFICATE

The holder of this certificate may work in companies dedicated to the assembly and/or maintenance of service distribution networks and systems and industrial fluid systems (not including electrical and fluidised solids systems), which capture, store, pump, distribute and control water, steam and other fluids. The work is mainly in the assembly, definition and planning departments of maintenance. The performance of some of the activities included in the qualification may require a professional licence issued by the competent government authority. The holder may work on the assembly and maintenance of facilities, in the sub-sectors of assembly and maintenance of fluid distribution networks and systems for buildings, industrial processes and/or production support processes. The most pertinent occupations and positions are:

- Technical planner and programmer of fluid distribution network and system maintenance.
- Assembly team leader of fluid distribution network and systems.
- Maintenance team leader of fluid distribution network and systems.
- Fluid distribution network and systems technician.

The holder of this professional certificate has recognition of the basic level training in labour risk prevention, according to Annex IV of the Royal Decree 39/1997 of 17 of January approving the Labour Risks Prevention Act.

#### 5. OFFICIAL BASIS OF THE CERTIFICATE

## Name and status of the national/regional authority providing accreditation/recognition of the certificate

The Ministry of Employment and Social Security or the corresponding autonomous regional administration within the scope of its competence, in the name of the King. The certificate is valid throughout Spain.

#### Level of the certificate

The Professional Certificate Level 3 of the National Repertoire of Professional Certificates corresponds to level 4 of the International Standard Classification of Education (ISCED-P 2011).

The European Qualification Framework (EQF) level:

#### **Grading scale/Pass requirements**

The grading scale and pass level of the training modules are expressed on a scale of 0 to 10. The minimum score for a pass is 5 in every training module including a pass in the practical training at the workplace module.

The grading system is as follows:

- FAIL: 0 to 4.9

PASS-SATISFACTORY: 5 to 6.9

PASS-GOOD: 7 to 8.9PASS-EXCELLENT: 9 to 10

#### Access to next level of education/training

This Professional Certificate Level 3 gives access to Professional Certificate Level 3 within the same professional area and family.

For validation purposes, the educational authorities will recognise the professional module or modules of the VET diplomas corresponding to the skills units included in the training modules of this certificate.

### **Legal basis**

Royal Decree 715/2011 of 20 May, establishing ten professional certificates in the professional family Installation and Maintenance, which are included in the National Repertoire of Professional Certificates, and updating the professional certificates established in Royal Decree 1375/2009 of 28 August. ## 6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

This certificate may be acquired by:

- 1. Training: Completion with a pass grade of the face-to-face or online training programme.
- 2. Recognition of the professional skills acquired through professional experience or non-formal training (prior learning): Completion of a process of skills evaluation and accreditation in all the skills units making up the professional certificate.
- 3. Dual training: Completion of a training and apprenticeship contract, which may range from 1 year (or 6 months, if stipulated as such in the collective agreement) to 3 years, during which effective working time is combined with time dedicated to training under the training programme for the professional certificate.

The training method (number 1 above) requires successful completion of the training modules and the practical training at the workplace:

#### **Entry/access requirements:**

- Bachiller Diploma (upper secondary education); or
- Professional Certificate Level 2 in the same professional area.
- If neither of the above or higher certifications are held, a pass in the key skills tests.

**Additional information:** Professional certificates are instruments for official accreditation of the professional qualifications in the National Catalogue of Professional Qualifications for all economic activities, within the scope of the labour administration. The National Repertoire of Professional Certificates is divided into three qualification levels (Level 1, Level 2 and Level 3), and by sectors into 26 professional families and 102 professional areas.
