3. PROFILE OF SKILLS AND COMPETENCES

The holder of this certificate will have acquired the **general competence** to manage a unit or section in the fishery product industry, programming, preparing and supervising the material and human resources, as well as the work needed to achieve the objectives set out in the production quality and environmental protection plans. In addition, to carry out the supervision of good manufacturing and handling practices; control the application of the traceability system; carry out supervision of the application of the system of hazard analysis and critical control points. This general competence is divided into the following **skills units** (UC):

- Manage supplies, storage and dispatch in the food industry and carry out sales support activities (UC0556_3).
- Program and manage production in the food industry (UC0557_3).
- Cooperate on the implementation and development of a quality and environmental management plan in the food industry (UC0558_3).
- Develop the processes and determine the operating procedures for the preparation of fishery and aquaculture products (UC0565_3).
- Control the preparation of fishery and aquaculture products and their automated production systems (UC0566_3).
- Apply analytical and sensory control techniques for the process of producing fishery and aquaculture products (UC0567_3).

The professional skills are acquired through the **learning outcomes** defined within the related Training Modules (MF):

- Storage and commercialization management in the food industry (MF0556_3).
- Organisation of a food production unit (MF0557_3).
- Quality and environmental management in the food industry (MF0558_3).
- Processes in the industry of fishery and aquaculture products (MF0565_3).
- Preparation of fishery and aquaculture products (MF0566_3).
- Analytical and sensory control of fishery and aquaculture products (MF0567_3).
- Practical training at the workplace in fishery and aquaculture product industry (MP0331)

As a reference the learning outcomes include in the Practical training at the workplace that complete and reinforce the learning outcomes acquired in the other training modules, are:

- Apply methods for the supply of goods used in the manufacture of fish derivatives and the organisation of sales of the finished products.
- Use procedures for planning, organisation and control of production in the fishery industry.
- Take part in the development of the company's quality and environmental protection objectives, in accordance with the established management model.
- Prepare quality and environmental records, proposing actions to improve the process and product.
- Supervise the machinery and equipment for preparing and producing fish products, as well as the ancillary service facilities.
- Carry out tasks for the reception and internal distribution of materials used for production of fish derivatives and apply prior treatment to raw materials for subsequent production, following instructions and procedural manuals.
- Manufacture fish derivative products, handling the materials and equipment needed, wrapping and packing the products and storing them, following procedures established for the purpose.
- Take part in the company's working processes, following the rules and instructions established at the workplace.

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THIS CERTIFICATE

The holder of this certificate may work in the industry of derivatives and fishery and aquaculture products, in small, medium-sized and large companies, as well as factory shops and fish markets. The holder may work in: fish preserve and semi-preserve producers; freezing and factory ships; shellfish-cleaning stations, live wells and stock ponds; fish farms; fish markets; fish freezing and distribution companies; cooked and pre-cooked fish producers; producers of ready meals; prepared food producers; fish processing industries (smoked, surimi, dried, soused and cured). The most pertinent occupations and positions are:

- Food industry worker.
- Line or plant manager in the fishery derivatives and aquaculture product industry.
- Quality control industry technician.
- Food industry laboratory analyst.
- Fishery and aquaculture product quality control laboratory analyst.
- Manager of small canning or fish processing industries.
- Sales technician for fishery and aquaculture derivatives and products.
- Fishery and aquaculture supplier.

5. OFFICIAL BASIS OF THE CERTIFICATE

Name and status of the national/regional authority providing accreditation/recognition of the certificate The Ministry of Employment and Social Security or the corresponding autonomous regional administration within the scope of its competence, in the name of the King. The certificate is valid throughout Spain.

Level of the certificate

The Professional Certificate Level 3 of the National Repertoire of Professional Certificates corresponds to level 4 of the International Standard Classification of Education (ISCED-P 2011).

The European Qualification Framework (EQF) level:

Grading scale/Pass requirements

The grading scale and pass level of the training modules are expressed on a scale of 0 to 10. The minimum score for a pass is 5 in every training module including a pass in the practical training at the workplace module. The grading system is as follows:

- FAIL: 0 to 4.9
- PASS-SATISFACTORY: 5 to 6.9
- PASS-GOOD: 7 to 8.9
- PASS-EXCELLENT: 9 to 10

Access to next level of education/training

This Professional Certificate Level 3 gives access to Professional Certificate Level 3 within the same professional area and family.

For validation purposes, the educational authorities will recognise the professional module or modules of the VET diplomas corresponding to the skills units included in the training modules of this certificate.

Legal basis

Royal Decree 646/2011 of 9 May, establishing thirteen professional certificates in the professional family Food Industry, which are included in the National Repertoire of Professional Certificates, and updating the professional certificate established as Appendix I of Royal Decree 1380/2009 of 28 August. 6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

This certificate may be acquired by:

- 1. Training: Completion with a pass grade of the face-to-face or online training programme.
- 2. Recognition of the professional skills acquired through professional experience or non-formal training (prior learning): Completion of a process of skills evaluation and accreditation in all the skills units making up the professional certificate.
- 3. Dual training: Completion of a training and apprenticeship contract, which may range from 1 year (or 6 months, if stipulated as such in the collective agreement) to 3 years, during which effective working time is combined with time dedicated to training under the training programme for the professional certificate.

The training method (number 1 above) requires successful completion of the training modules and the practical training at the workplace:

Entry/access requirements:

- Bachiller Diploma (upper secondary education); or
- Professional Certificate Level 2 in the same professional area.
- If neither of the above or higher certifications are held, a pass in the key skills tests.

Additional information: Professional certificates are instruments for official accreditation of the professional qualifications in the National Catalogue of Professional Qualifications for all economic activities, within the scope of the labour administration. The National Repertoire of Professional Certificates is divided into three qualification levels (Level 1, Level 2 and Level 3), and by sectors into 26 professional families and 102 professional areas.
