3. PROFILE OF SKILLS AND COMPETENCES

The holder of this certificate will have acquired the **general competence** to define and develop furnishing projects and projects for the installation of carpentry and furniture in homes and public locations, including the supervision of the installation and operations needed for this, to the required quality levels and in the appropriate occupational health and safety and environmental conditions. This general competence is divided into the following **skills units** (UC):

- Develop projects for installing carpentry and furnishing in homes, commercial establishments, and exhibition and public areas (UC1369_3).
- Supervise the supply and manufacture of elements for the installation of carpentry and furniture (UC1370_3).
- Coordinate and supervise the assembly of carpentry and furniture installations (UC1371_3).

The professional skills are acquired through the **learning outcomes** defined within the related Training Modules (MF):

- Develop installation and furnishing projects (MF1369_3).
- Supply elements for the installation of carpentry and furnishing (MF1370_3).
- Supervision of the assembly of carpentry and furnishing installations (MF1371_3).
- Practical training at the workplace in installation and furnishing projects (MP0290)

As a reference the learning outcomes include in the Practical training at the workplace that complete and reinforce the learning outcomes acquired in the other training modules, are:

- Take part in the representation and design of the space for the installation and furnishing project.
- Take part in the definition of construction solutions, selecting them according to the objectives, materials and means available.
- Collaborate on preparing the budgets for installation and furnishing, specifying the items and deadlines.
- Assist in the planning of the supply of materials and products for the installation and furnishing.
- Check the reception of the different products, components and accessories, ensuring their quality.
- Collaborate on the planning of the dispatch and shipping of materials for installation.
- Provide support for the installation process, taking into account the human and technical factors involved.
- Take part in the company's working processes, following the rules and instructions established at the workplace.

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THIS CERTIFICATE

The holder of this certificate may work in the installation area of companies dedicated to the manufacture, sale and installation of carpentry and furniture elements, as well as companies dedicated to the production of installation elements. The holder may work in the following productive sectors: carpentry and furniture installation projects; the installation of carpentry and furniture elements; and the sale of carpentry elements. The most pertinent occupations and positions are:

- Wood and cork company manager.
- Carpentry and furniture designer.

<p style="text-align: center;">Level of the certificate</p> <p>The Professional Certificate Level 3 of the National Repertoire of Professional Certificates corresponds to level 4 of the International Standard Classification of Education (ISCED-P 2011).</p> <p>The European Qualification Framework (EQF) level:</p>	
<p style="text-align: center;">Grading scale/Pass requirements</p> <p>The grading scale and pass level of the training modules are expressed on a scale of 0 to 10. The minimum score for a pass is 5 in every training module including a pass in the practical training at the workplace module.</p> <p>The grading system is as follows:</p> <ul style="list-style-type: none"> - FAIL: 0 to 4.9 - PASS-SATISFACTORY: 5 to 6.9 - PASS-GOOD: 7 to 8.9 - PASS-EXCELLENT: 9 to 10

<p style="text-align: center;">Legal basis</p> <p>Royal Decree 1532/2011 of 31 October, establishing seven professional certificates in the professional family Wood, Furniture and Cork, which are included in the National Repertoire of Professional Certificates. (Appendix V, Code: MAMB0110)</p>	

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE		
<p>This certificate may be acquired by:</p> <ol style="list-style-type: none"> 1. Training: Completion with a pass grade of the face-to-face or online training programme. 2. Recognition of the professional skills acquired through professional experience or non-formal training (prior learning): Completion of a process of skills evaluation and accreditation in all the skills units making up the professional certificate. 3. Dual training: Completion of a training and apprenticeship contract, which may range from 1 year (or 6 months, if stipulated as such in the collective agreement) to 3 years, during which effective working time is combined with time dedicated to training under the training programme for the professional certificate. <p>The training method (number 1 above) requires successful completion of the training modules and the practical training at the workplace:</p>

Entry/access requirements:

- *Bachiller* Diploma (upper secondary education); or
- Professional Certificate Level 2 in the same professional area.
- If neither of the above or higher certifications are held, a pass in the key skills tests.

Additional information: Professional certificates are instruments for official accreditation of the professional qualifications in the National Catalogue of Professional Qualifications for all economic activities, within the scope of the labour administration. The National Repertoire of Professional Certificates is divided into three qualification levels (Level 1, Level 2 and Level 3), and by sectors into 26 professional families and 102 professional areas.
