## **3. PROFILE OF SKILLS AND COMPETENCES**

The holder of this certificate will have acquired the **general competence** to carry out air pollution sampling and pollution control devices in accordance with current law and to operate, maintain and check the monitoring equipment and facilities for the purification and control of pollutant emissions. This general competence is divided into the following **skills units** (UC):

- Operate devices for the monitoring and sampling of air pollutants, carrying out first-level maintenance of them (UC1613\_3).
- Keep up-date information on the regulations and documentation generated internally associated with air pollution control (UC1614\_3).
- Sample and measure air pollution monitoring (UC1615\_3).
- Operate different facilities for purification and control of pollutant emissions and carry out first-level maintenance of them (UC1616\_3).

The professional skills are acquired through the **learning outcomes** defined within the related Training Modules (MF):

- Air pollution control equipment (MF1613\_3).
- Air pollution regulations (MF1614\_3).
- Sampling and measurement of air pollutants (MF1615\_3).
- Purification and control of air pollutants emissions (MF1616\_3).
- Practical training at the workplace in Monitoring of air pollution (MP0401)

(See legal basis for all learning outcomes information acquired by the holder of this Certificate in each MF). As a reference the learning outcomes include in the Practical training at the workplace that complete and reinforce the learning outcomes acquired in the other training modules, are:

- Apply specific maintenance protocols for sampling and measurement of air pollutants equipments.
- Manage information and documentation related to the monitoring of air pollution.
- Take representative samples and measures to be transferred to other cases in predefined conditions.
- Control and purify air pollutant emissions with mechanical, electrical or monitoring equipment.
- Take part in the company's working processes, following the rules and instructions established at the workplace.

## 4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THIS CERTIFICATE

The holder of this certificate may work in any sectors that have potential air pollutants, particularly in the industrial sector. The holder may work in the service sector associated with the control of air pollution and in air pollution control laboratories.

The most pertinent occupations and positions are:

- Sampling air pollutants technician.
- Air pollution monitoring technician.
- Technician working in analysis and measurement associated with the control of air pollution.

## 5. OFFICIAL BASIS OF THE CERTIFICATE

Name and status of the national/regional authority providing accreditation/recognition of the certificate The Ministry of Employment and Social Security or the corresponding autonomous regional administration within the scope of its competence, in the name of the King. The certificate is valid throughout Spain.

#### Level of the certificate

The Professional Certificate Level 3 of the National Repertoire of Professional Certificates corresponds to level 4 of the International Standard Classification of Education (ISCED-P 2011).

# Grading scale/Pass requirements

The grading scale and pass level of the training modules are expressed on a scale of 0 to 10. The minimum score for a pass is 5 in every training module including a pass in the practical training at the workplace module. The grading system is as follows:

- FAIL: 0 to 4.9
- PASS-SATISFACTORY: 5 to 6.9
- PASS-GOOD: 7 to 8.9
- PASS-EXCELLENT: 9 to 10

#### Access to next level of education/training

This Professional Certificate Level 3 gives access to Professional Certificate Level 3 within the same professional area and family.

For validation purposes, the educational authorities will recognise the professional module or modules of the VET diplomas corresponding to the skills units included in the training modules of this certificate.

#### Legal basis

Royal Decree 1785/2011 of 16 December, establishing two professional certificates in the professional family Security and Environment, which are included in the National Repertoire of Professional Certificates. (Appendix I, Code: SEAG0111)

## 6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

This certificate may be acquired by:

- 1. Training: Completion with a pass grade of the face-to-face or online training programme.
- Recognition of the professional skills acquired through professional experience or non-formal training (prior learning): Completion of a process of skills evaluation and accreditation in all the skills units making up the professional certificate.
- 3. Dual training: Completion of a training and apprenticeship contract, which may range from 1 year (or 6 months, if stipulated as such in the collective agreement) to 3 years, during which effective working time is combined with time dedicated to training under the training programme for the professional certificate.

The training method (number 1 above) requires successful completion of the training modules and the practical training at the workplace:

Entry/access requirements:

- Bachiller Diploma (upper secondary education); or
- Professional Certificate Level 2 in the same professional area.
- If neither of the above or higher certifications are held, a pass in the key skills tests.

**Additional information:** Professional certificates are instruments for official accreditation of the professional qualifications in the National Catalogue of Professional Qualifications for all economic activities, within the scope of the labour administration. The National Repertoire of Professional Certificates is divided into three qualification levels (Level 1, Level 2 and Level 3), and by sectors into 26 professional families and 102 professional areas.
