3. PROFILE OF SKILLS AND COMPETENCES

The holder of this certificate will have acquired the **general competence** to plan, organise, manage, promote and evaluate all the aspects of projects for educational leisure activities aimed at children and young people, being responsible for them within the programme and beyond it, and taking on the creation, control and leadership of the team of monitors. This general competence is divided into the following **skills units** (UC):

- Plan, organise, manage and evaluate projects for educational leisure activities (UC1869_3).
- Act in group activities according to the behaviour and characteristics of the children and young people (UC1867_2).
- Use educational techniques and resources for leisure activities (UC1868_2).
- Create teams of monitors, encouraging them and supervising them in educational leisure projects for children and young people (UC1870_3).

The professional skills are acquired through the **learning outcomes** defined within the related Training Modules (MF):

- Planning, organisation, management and evaluation of educational leisure projects for children and young people (MF1869_3).
- Group and educational leisure activities for children and young people (MF1867_2).
- Entertainment techniques and resources in leisure activities (MF1868_2).
- Coordination and leadership of a team of leisure monitors (MF1870_3).
- Practical training at the workplace in monitoring of management and coordination of educational leisure activities for children and young people (MP0410)

(See legal basis for all learning outcomes information acquired by the holder of this Certificate in each MF). As a reference the learning outcomes include in the Practical training at the workplace that complete and reinforce the learning outcomes acquired in the other training modules, are:

- Develop a leisure educational programme.
- Organise and implement leisure programming for children and young people.
- Direct and coordinate a team of monitors.
- Show relationship and empathy skills.
- Take part in the company's working processes, following the rules and instructions established at the workplace.

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THIS CERTIFICATE

The holder of this certificate may work in the sector of educational leisure activities for children and young people, in a variety centres or facilities such as: civic centres, children's centres, cultural centres, clubs, leisure centres and free time educational associations/groups, youth centres, urban camps, play centres, hostels, camping areas and camps, summer camp houses, educational farms, nature workshops and schools, educational leisure areas in shopping centres, school centres, transport for children and young people, associations, working camps, youth exchanges, etc.

The most pertinent occupations and positions are:

- Leisure activities coordinator.
- Educational leisure activities coordinator for children and young people.
- Children and young people's leisure activities manager.
- Head of children and young people's educational leisure projects.
- Coordinator/Director of camps, youth hostels, summer camp houses, educational farms, youth house workshops and nature schools.
- Coordinator/Director of paracurricular activities in the school.

5. OFFICIAL BASIS OF THE CERTIFICATE

Name and status of the national/regional authority providing accreditation/recognition of the certificate The Ministry of Employment and Social Security or the corresponding autonomous regional administration within the scope of its competence, in the name of the King. The certificate is valid throughout Spain.

Level of the certificate

The Professional Certificate Level 3 of the National Repertoire of Professional Certificates corresponds to level 4 of the International Standard Classification of Education (ISCED-P 2011).

The European Qualification Framework (EQF) level:

Grading scale/Pass requirements

The grading scale and pass level of the training modules are expressed on a scale of 0 to 10. The minimum score for a pass is 5 in every training module including a pass in the practical training at the workplace module. The grading system is as follows:

- FAIL: 0 to 4.9
- PASS-SATISFACTORY: 5 to 6.9
- PASS-GOOD: 7 to 8.9
- PASS-EXCELLENT: 9 to 10

Access to next level of education/training

This Professional Certificate Level 3 gives access to Professional Certificate Level 3 within the same professional area and family.

For validation purposes, the educational authorities will recognise the professional module or modules of the VET diplomas corresponding to the skills units included in the training modules of this certificate.

Legal basis

Royal Decree 1697/2011 of 18 November, establishing five professional certificates in the professional family Sociocultural and Community Services, which are included in the National Repertoire of Professional Certificates. (Appendix II, Code: SSCB0211)

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

This certificate may be acquired by:

- 1. Training: Completion with a pass grade of the face-to-face or online training programme.
- Recognition of the professional skills acquired through professional experience or non-formal training (prior learning): Completion of a process of skills evaluation and accreditation in all the skills units making up the professional certificate.
- 3. Dual training: Completion of a training and apprenticeship contract, which may range from 1 year (or 6 months, if stipulated as such in the collective agreement) to 3 years, during which effective working time is combined with time dedicated to training under the training programme for the professional certificate.

The training method (number 1 above) requires successful completion of the training modules and the practical training at the workplace:

Entry/access requirements:

- Bachiller Diploma (upper secondary education); or
- Professional Certificate Level 2 in the same professional area.
- If neither of the above or higher certifications are held, a pass in the key skills tests.

Additional information: Professional certificates are instruments for official accreditation of the professional qualifications in the National Catalogue of Professional Qualifications for all economic activities, within the scope of the labour administration. The National Repertoire of Professional Certificates is divided into three qualification levels (Level 1, Level 2 and Level 3), and by sectors into 26 professional families and 102 professional areas.
